February Monthly Meeting Recap



Our 16 February luncheon's distinguished speaker was Rear Admiral Andrew J. Tiongson, Assistant Commandant for Resources and Chief Financial Officer of the United States Coast Guard. Continuing with our 2017 theme of "Supporting the War Fighter with Solid Financial Information", Rear Admiral Tiongson provided detailed insight into the Coast Guard's ongoing efforts to improve mission support for operational commanders across the organization through improved financial management.

During his discussion, Rear Admiral Tiongson shared an overview of the Coast Guard budget from a macro perspective and outlined initiatives the service has undertaken to modernize and improve its financial management and procurement services. He began by highlighting the Coast Guard's current budget state and outlining some of the ongoing efforts impacting it, such as recapitalization, the new blended retirement system for the military, and identifying funding for emerging programs such as cyber. He further discussed current modernization efforts, prompted by audit needs, but also by how the Coast Guard's current financial structure is very challenging to optimize due to unit geographic diversity. For example, with numerous small stations and cutters located along rivers, lakes, and coastlines, many financial management responsibilities fall upon the command cadre, rather than specialized personnel.

To achieve success in its effort to modernize its financial management procurement services, Rear Admiral Tiongson outlined how the Coast Guard developed a process involving three primary components, known as Financial Management and Procurement Services (FMPS), whose Integration Team was stood up in 2012. The first component is the Business Process Re-engineering (BPR) effort, designed to shift the Coast Guard away from custom-designed processes and unique workarounds toward standardization, compliance, and improved operational support. Second is the Financial Management System Improvement Initiative (FMSII), a multi-year initiative that will replace the Coast Guard's existing accounting systems. The third and final component is a Data Strategy Team designed to lead the migration of legacy data into the new system.

To highlight some of the benefits of these modernization efforts, Rear Admiral Tiongson discussed positive effects seen thus far that include a reduction in the number of purchase card holders in the Coast Guard. This reduced the cost and administrative burden associated with the management of purchase cards, and improved compliance with purchase request Segregation of Duties Requirements resulted in a 25.2% increase. Most importantly, day-to-day financial management and procurement responsibilities are shifting from operators to financial professionals located at regional support units, thereby relieving operational commanders of this burden and allowing them to focus on execution of their core missions. To better manage the impacts of modernization, the Coast Guard is using a phased approach, which began as an initial pilot program in its District 5 region, and has now expanded to three other districts using lessons learned from the initial pilot program.

In closing, Rear Admiral Tiongson stressed how the Coast Guard is growing and supporting its financial management community, and how our human capital strategy, a top priority for the Commandant, is demonstrating its success by the financial management community's progress. For example, financial management is now an established military officer specialty with a viable career path, the Coast Guard currently has over 30 CPAs and has greatly expanded the number of Coast Guard personnel who hold either or both the CDFM or CGFM designations. In summary, financial management modernization is one initiative that is definitely moving the Coast Guard ahead.

Mrs. Hammersley is the Deputy Chief Information Officer for Resources & Analysis within the office of the DoD Chief Information Officer (DoD CIO). Key responsibilities include serving as the DoD CIO focal point for the Planning, Programming, Budgeting and Execution process, Congressional issues, Information Management issues and for CIO Administration & Management. This position was formerly the Deputy Assistant Secretary of Defense for Resources within the Office of the Assistant Secretary of Defense (Networks & Information Integration)/DoD Chief Information Officer).

From June 2002 to November 2007, Mrs. Hammersley was the Director of the Resource, Program & Budget Office within DASD(Resources). The responsibilities included generating the DoD Information Technology budget and associated budget justification materials provided to both the Office of Management and Budget and the Congress. From June 2001 to June 2002, she was the Special Assistant to DASD (Resources) and played a key role in the 2001 Quadrennial Defense Review and the various emergency supplementals (e.g. Defense Emergency Response Fund) in support of the aftermath of September 11, 2001.

Hammersley is a native of Columbus, Ohio and a graduate of The Ohio State University where she received her B.S. in Ceramic Engineering. She is also a graduate of the Naval War College, a 1993-1994 fellow of the Massachusetts Institute of Technology's Seminar XXI Program (Foreign Politics, International Relations, and the National Interest) and a former member of the Defense Leadership and Management Program. Mrs. Hammersley is a 2004 Presidential Meritorious Rank Award recipient and a 2014 Presidential Distinguished Rank Award recipient.

May Meeting Guest Speaker



David Fisher has been successfully leading business transformation programs in both the public and private sectors for nearly 20 years. Currently he is leading the Public Sector Risk Consulting Practice for PricewaterhouseCoopers (PwC), with a particular focus on assisting Federal agencies to design, implement, and fully operationalize Enterprise Risk Management (ERM) programs. As a former Chief Risk Officer at the Internal Revenue Service (IRS) who stood up the organization's first ERM program, Mr. Fisher recognizes that ERM solutions require cultural adaptation around the mindsets and behaviors that are essential to enabling enterprise-wide risk transparency, along with the mechanisms that must be established to enable efficient and effective identification and management of the organization's highest priority portfolio of risks.

At the IRS, Mr. Fisher's office established ERM governance and operating models that provided the means for senior leaders to engage with ongoing top-down guidance, prioritization, and critical decision-making, while also fostering a bottom-up set of capabilities to capture, socialize, and analyze risks as they were being identified throughout the organization. He led the Agency through its first enterprise risk assessment, including actions items directed by the Executive Risk Committee for which he served as the Chair.

Mr. Fisher spent nearly ten years as a senior executive in the Federal government, leading transformation efforts across at the Department of Defense (DoD), the Government Accountability Office (GAO), and the IRS. At DoD, he served as the first permanent Director of the newly established Business Transformation Agency (BTA). In this capacity, Mr. Fisher served as a direct report to DoD's Deputy Chief Management Officer, with an agency budget of ~\$350 million, and oversight responsibility for more than \$2 billion in DoD's annual IT modernization spending. He served as the chief executive for the agency which included directorates focused on DoD-wide process and functional business requirements, data standards, IT investment management, enterprise integration, unique warfighter business requirements for contingency operations, and a business systems acquisition portfolio that consisted of more than 20 DoD-wide IT programs. In recognition of his service and accomplishments, Mr. Fisher was awarded the Secretary of Defense Medal for Exceptional Civilian Service.

Mr. Fisher's government service followed to the Legislative Branch where he served as the Chief Administrative Officer / Chief Financial Officer at GAO. Working directly for the Comptroller General and as a member of the Agency's four-person Executive Committee, his management responsibilities encompassed all internal operations, including budget (~\$500 million), financial management and audit, internal controls, human resources, IT, business process reengineering (BPR), procurement, publishing, facilities, security, and field operations. As the agency's Co-Performance Improvement Officer, he led an end-to-end BPR initiative that identified 31 recommendations to improve mission efficiency without compromising quality, and led the implementation of many of those recommendations. Mr. Fisher was a recipient of the Comptroller General Award (the Agency's highest honor) in only his second year at GAO.

In addition to his duties at each of these agencies, Mr. Fisher also served on the initial Financial Systems Advisory Board, which was chartered to provide recommendations to the Office of Management & Budget on financial system modernization projects from across the entire Federal government. The Board reviewed all current or planned federal financial system modernization projects, taking a risk-based approach to yield recommendations on how best to achieve desired outcomes. These recommendations, as adopted by OMB and Federal Agencies, yielded savings of approximately \$1.6 billion for the government.

Mr. Fisher is a graduate of Stanford University, and received his MBA from Santa Clara University's Leavey School of Business and Administration where he earned the Dean's Award for Scholarship. He is the author of the book, *Optimize Now (or else!): How to Leverage Processes and Information to Achieve Enterprise Optimization (and Avoid Enterprise Extinction)*.

This year's theme, "DoD FM: Outcomes Matter!" refers to the criticality of FY2017 as the statutory deadline for DoD "outcomes" – to assert full financial statement audits. After many years of significant work, our military, civilian, and contractor professionals have challenged the status quo, modernized IT, improved operational effectiveness and enhanced professional advancement. Critical goals of standardization and simplification in our business environment will accelerate audit outcomes as well as sustainability.

Early afternoon breakout sessions included: DoD Audit Update; Strategic FM Human Capital Development; Taking Care of People; Legislative Update; 2016 ASMC Survey Results; and FY18-19 Budget Update.

In conjunction with our formal program, our new Corporate "Thought Leadership Bursts" from our Platinum and Diamond level sponsors (CPE/CET) during our morning and afternoon breakout sessions were well-received. ELIGIBILITY CRITERIA FOR THE SCHOLARSHIP:

- Applicant must be a Gov't member in good standing of the Washington ASMC chapter. Applicant must have been a member prior to the submission due date. Corporate members are not eligible for this award.
- Applicant must be a full-time government employee (either military or civilian).
- Applicant must be working toward an undergraduate or graduate degree in a business-related or resource management field of study relating to military comptrollership - e.g., business administration (to include management, budget, cost analysis), economics, accounting, finance, audit, information systems, and statistics.
- Applicant must possess a minimum grade point average of 3.0 on a 4.0 scale.
- Applicant must not have been previously selected for the Scholarship.

Applications must be postmarked or emailed by **March 31, 2017**. There are no exceptions to this deadline. Any applications received incomplete or after this date will not be considered for selection.

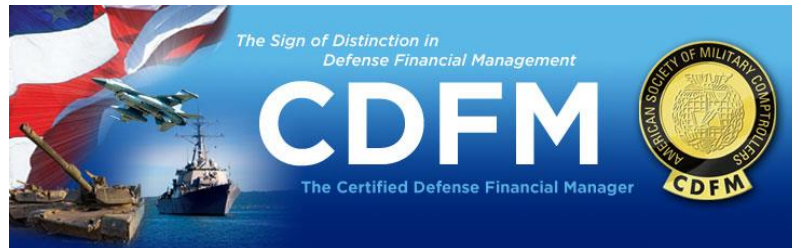

While most candidates in the CDFM program are civilian or military/reserve members of the Department of Defense, U.S. Coast Guard, U.S. Army, U.S. Air Force, U.S. Navy, U.S. Marine Corps or employees of defense contractors or suppliers, the CDFM program is open to all candidates who have a high school diploma (or equivalent) and meet the following work experience qualifications:

Have the required number of years of defense-related financial management experience outlined below:

- **Two (2) years if you hold an Associate's degree or higher;** or
- **Three (3) years if you do not have a degree.**

OR

Do not have defense-related financial management experience, but can meet the following criteria outlined below:

- **Four (4) years of Federal government-related financial management experience;** and
- **An Associate's degree or higher.**

There are three steps involved with earning your CDFM:

1. Enroll in the CDFM Program. Your enrollment is valid for two (2) years, during which time you must take, and successfully pass, the three CDFM module examinations.

2. Submit Your Verification of Financial Management Experience Form. This form, which must be signed by a supervisor who can verify your work experience, must be returned to ASMC after enrolling in the CDFM program. You do not have to submit this form prior to taking a CDFM examination, but it is required prior to the awarding of the CDFM designation.

3. Purchase and Schedule the CDFM Examinations. Be sure to carefully – and completely – read the criteria associated with each testing option for the CDFM examinations. Failure to do so can result in the purchase of the wrong CDFM examination and/or the inability to test at your preferred location
