HISTORY OF INDUSTRY LIAISON GROUPS

Industry Liaison Groups (ILGs) are a concept first spawned by the U.S. Department of Labor's Office of Federal Contract Compliance Programs (OFCCP) in the early 1980's to encourage open communication between industry and the OFCCP. The Alabama Industry Liaison Group and its peer organizations around the country represent a unique partnership of public- and private-sector cooperation. Today, there are over 60 ILG chapters in the six (6) OFCCP regions across the U.S., representing thousands of contractor organizations. The National ILG (NILG) and each of its chapters are independent of the OFCCP and include only those contractors, constituency and other groups who wish to participate. The NILG sponsors an annual education conference, which was attended by over 850 ILG members in 2011.
