This Release and Waiver of Liability, (the "Release") executed on this ____ day of _____, 20__, by _____, the Volunteer, in favor of Ogden UnCon LLC, their directors, officers, employees, and agents.

The Volunteer desires to work as a volunteer for Ogden UnCon LLC (the "Convention") and engage in activities related to being a volunteer (the "Activities"). The Volunteer understands that the Activities may include but are not limited to, interacting with customers, vendors, and guests, providing clerical support, loading and unloading supplies, lifting and moving Convention related furniture or materials, basic maintenance, so on and so forth. The Volunteer does hereby freely, voluntarily, and without duress execute this Release under the following terms:

1. **RELEASE AND WAIVER:** Volunteer, for him/herself and his or her legal representatives, spouse, heirs and assigns, does hereby release and forever discharge and hold harmless the Convention, and its officers, directors, trustees, employees, agents, insurers and representatives, successors and assigns from any and all liability claims and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with the Convention.

Volunteer understands that this Release discharges the Convention from any liability or claim that the Volunteer may have against the Convention with respect to any bodily injury, personal injury, illness, death or property damage that may result from Volunteer's Activities with the Convention whether caused by the negligence of the the Convention or its officers, directors, employees, or agents, or otherwise. Volunteer covenants not to bring any action against the Convention for any such injury or damage. Volunteer also understands that the Convention does not assume any responsibility for or obligation to provide financial or other assistance including but not limited to medical, health, or disability insurance in the event of injury or illness.

2. **MEDICAL TREATMENT:** Volunteer does hereby release and forever discharges the Convention from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with the Convention. Volunteer authorizes the Convention to act, in its best judgement, on Volunteer's behalf in case of an emergency.
3. **ASSUMPTION OF THE RISK:** The Volunteer understands that the Activities may include work that may be hazardous to the Volunteer, including but are not limited to, interacting with customers, vendors, and guests, providing clerical support, loading and unloading supplies, lifting and moving Convention related furniture or materials, basic maintenance, so on and so forth.

Volunteer hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases the Convention from all liability for injury, illness, death, or property damage resulting from the Activities.

4. **VOLUNTARY SERVICE:** Volunteer understands and acknowledges that he/she may decline any volunteer role or position at any time if he/she feels such a role or position presents a risk to health or safety or for any other reason. Volunteer agrees to advise the Convention of any preexisting conditions that would preclude involvement in any activity.
5. **INSURANCE:** The Volunteer understands that, except as otherwise agreed upon by the Convention in writing, the Convention does not carry or maintain health, medical, disability, or Workers Compensation insurance coverage for any volunteer.
6. **OTHER:** Volunteer expressly agrees that the Release is intended to be as broad and inclusive as permitted by the laws of the State of Utah, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Utah. Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which will continue to be enforceable.

PHOTOGRAPHIC RELEASE: Volunteer does hereby grant and convey unto the Convention all rights, title, and interest in any and all photographic images and video or audio recordings made by the Convention, during the Volunteer's Activities with the Convention, including, but not limited to, any donations, proceeds, or other benefits derived from such photographs or recordings.
