




#### Don't delay!

## **POWER OF ATTORNEY**

By organising a Power of Attorney you can plan who you want to act on your behalf in the future, should you be unable to make your own decisions about your own affairs. A Power of Attorney is a written document, which must include a certificate signed either by a practising solicitor, practising member of the Faculty of Advocates or a registered medical practitioner in Scotland.

We can help you to draft your Power of Attorney, and, once signed, we will arrange to register it with the Office of Public Guardian Scotland.

The law states that someone who is currently declared as bankrupt or if a protected trust deed is in place that they can make a Power of Attorney to deal with their personal welfare decision making but not about their financial and property affairs.


Once the Power of Attorney is registered, it will last unless you decide to cancel it. There are various other reasons for a Power of Attorney to come to an end, such as, on your death, or, the death of a sole attorney (with no substitute nominated).

### **Executries**


Our fees are calculated on an hourly rate of £200.00 plus vat per hour.
