• Meeting Called to Order: 7:30 PM

- Modification of Agenda: Fred added the December Tax Sale to Old Business.
- Approval of Minutes: Bill motioned to approve the Nov 11th and Nov 15th minutes. Fred seconded the motion; all were in favor.
- Budget Report: Nothing to report about the budget this month.
- Citizens' Concerns: Gary will address Roberta Horowitz regarding her plowing concerns on Stonybrook Rd.
- Town Board Representative: Jeffrey Gingue brought a budget proposal for the Waterford Fire Department, and brought up concerns about reliable response times during the day in case of emergencies. The board of listers are looking into exempting the first \$3,000 from the Inventory & Equipment Tax. They are working on getting the article wording from two other towns who have done so.
