- Planning Commission Amendment Proposal (Informational) public hear needs to be held between 20 and 120 days from the hearing date. Discussion at April meeting and set the hearing date. Adopt and then the town vote at the next town meeting.
   Amendments – regulating short term rentals, redistricting, helipad, new district (Higgin's Hill District – 1 acre lots was proposed.) Signage discussion. Hearing was on February 15 – needs to be held before June 15<sup>th</sup>. Website has the right version.

  - Jennifer Smith asked if the board had considered holding their meetings online again. The board will consider it depending on the location they choose for meetings.
