**4. Streets and Streetlights** – Councilman Ho – (absent) nothing to report


**5. Parks and Recreation** – Councilman Fitch – nothing to report

**6. Library** – Councilman Dubberly -nothing to report


**7. Grants** – Councilman Z. Gopaul – Nothing to report.
