**ORDER**

---

**WHEREAS** on May 12, 2008 the New Brunswick Securities Commission (Commission) issued an *ex parte* temporary order (Temporary Order) pursuant to subsections 184(1)(c), 184(1)(d) and 184(5) of the *Securities Act*, SNB 2004, c. S-5.5 as amended (*Act*) concerning the Respondents;

**AND WHEREAS** on May 15, 2008 the Commission issued a Notice of Hearing to be held on May 26, 2008 at 10:00 am;

**AND WHEREAS** the hearing was commenced on May 26, 2008 and then adjourned to 19 June 2008 to address the substantive issues;

**AND WHEREAS** on May 28, 2008 the Temporary Order was extended to June 20, 2008 pursuant to subsection 184(7) of the *Act*;

**AND WHEREAS** none of the Respondents appeared on 26 May 2008 and 19 June 2008 despite having received notice;

**AND WHEREAS** at the hearing on 19 June 2008, Staff of the Commission (Staff) requested an adjournment and an extension of the Temporary Order, which was extended on May 28, 2008 pending completion of their investigation and their preparation of an amended statement of allegations;

**AND WHEREAS** on 19 June 2008 the Commission issued an order extending the Temporary Order until the Commission reaches a final determination in this proceeding or until otherwise ordered by this Commission (Extension Order) and adjourning the hearing pending Staff's completion of their investigation;

**AND WHEREAS** Staff have completed their investigation and have withdrawn the proceedings against Evanna Tomeli, Robert Black, Richard Wylie, Jack Anderson and Jim Corcoran, and will not be filing an Amended Statement of Allegations;

**AND WHEREAS** the Panel conducted a hearing on 30 April 2009 and considered the evidence and submissions before it;

**AND WHEREAS** none of the Respondents appeared on 30 April 2009 despite having received proper notice;

**IT IS HEREBY ORDERED THAT** the 19 June 2008 Extension Order be continued with respect to the respondents Goldpoint Resources Corporation, Lino Novielli and Brian Moloney.
