Luncheon Recap

ASMC Washington Chapter September 2015 Luncheon – Remarks by Karen Fenstermacher, DASN(FO)

The Washington Chapter was pleased to have Karen Fenstermacher, the Deputy Assistant Secretary of the Navy (Financial Operations) as our guest speaker at the September luncheon. As the DASN (FO), Ms. Fenstermacher is the point person for Financial Improvement and Audit Readiness across the Department of the Navy enterprise. Ms. Fenstermacher addressed the topic of Financial Management and Stewardship, the Washington Chapter's theme for this year.

One of my roles – certainly my primary role – as DASN (Financial Ops) is to continue to make progress toward full financial statement auditability and eventually bring home a favorable audit opinion. I know a lot of you are helping the Navy-Marine Corps team out in that endeavor – I see some nods out there.

So, the auditability effort has got us all scrambling – we've never faced these particular challenges collectively as a Department. I like to pause once and a while from the helter-skelter pace and reflect on why we're doing what we're doing.

It's easy to say – we're doing it because Congress told us to do it, and indeed...they continue giving us direction each year in the authorization bills. They have frequent hearings that Dr. Rabern or I get to attend... to report to our elected reps on our audit progress. Sometimes we get a concerned lecture along with their pledge of support and help...

So, I tell myself, there has to be higher calling in this auditability stuff than merely "compliance." Sometimes, that's the only justification you'll get when you're a program manager. But luckily for my self-esteem, there's more to the auditability deal. So in addition to Congressional compliance – there's a second, equally as powerful, motivation.

And that's promoting a greater degree of stewardship in the way we do business as a Navy-Marine Corps team – which is also a nice fit with the theme of your gathering today.

So, how does getting ready for audit and then going thru yearly financial statement audits promote stewardship and better business practices? Those of you who are working audit-related issues now may have a pretty good understanding.

At the macro level, on the day that the department receives a favorable opinion on its financial statements, we'll be able to say we've achieved what public corporations and most other federal agencies have already accomplished – getting a gold star from independent auditors that our statements conform to accepted accounting standards and are fairly stated.

The auditors will issue that favorable opinion after thoroughly assessing our business processes and systems to see if their internal controls are strong and effective. That "clean" opinion means we're "in the club" and that we meet conventional standards.

But a colleague – or maybe your significant other – might not be quite as impressed... and challenge you with "a clean opinion – so what?"

At that point you could pay your bar bill and leave – or you could offer your companion a glimpse behind the audit curtain – a better perspective on what that clean opinion entails. And maybe you can give them a better understanding of other aspects – in addition to compliance – which are part of the audit value proposition...that stewardship factor, if you will.

The first aspect that I'll talk a little about is – reducing the risk of misusing funds – either inadvertently or overtly as fraud. Getting ready for a financial statement audit means taking a look at the internal controls you have in place governing your business processes and business systems – as you conduct your business ops – spending government funds for goods and services to support the warfighters.

Audit standards require controls which reduce this risk of funds misuse – controls which increase accountability in our business activity. Some examples – civilian pay: does a supervisor approve employee time before it's paid? In the contract payment process: does a 3-way match of contract, invoice, and receipt occur prior to any payment? Does this receipt and acceptance process also apply to reimbursable orders? Does a designated “approver” authorize your travel...and approve subsequent payments for travel?

These examples – of internal controls which conform to audit standards – are safeguards – which reduce the risk that funds are misused.

Similarly – on the IT business systems side – financial audit standards call for strong internal controls which prevent improper access to or use of business and financial information.

Here, the emphasis is on access controls – do your controls minimize the risk of unauthorized access to a business system? Are user access rolls properly policed to ensure they include only current employees? Are these controls adequately documented – meaning that you can prove to an auditor that these access controls are functioning properly?

Staying with IT system controls...there are also controls which call for separating the roles system users can assume when they operate in the system. Ideally, users should not be able to perform multiple roles in a system which would increase the risk of impropriety. To use a simple example, in DTS, subordinates should not be assigned as approving officials for their supervisor's travel, as has sometimes occurred. Not compliant...not good! So that's the concept of segregation of duties...which we should all embrace as stewards of the public trust...and of the public's funds.

In addition to minimizing the risk that funds could be misused – there another dimension to funds use that I'd also like to point out. And that's inefficient use, or under-utilization of funds, because of weak internal controls. The best example of this is – having an obligation on the books for a requirement that's no longer valid.

If that obligation lingers and the funds expire, well, you've just left money on the table. Those expiring funds could very well have been re-purposed for another requirement... and were the stale obligation detected in time, you could have extended your command's buying power. The best weapon to reduce this risk is a rigorous triannual review of obligations. (Not sure we've gotten max results from every triannual review conducted out there...)

I'd like to cite two instances where better management of obligations has yielded better buying power...by tightening controls and scrutiny.

RESFOR has found that better management of requisitions they have outstanding...monitoring supply status better and validating the requirements on order...has yielded millions in savings over a several year period.

BUMED has changed its contract close-out procedures. They're now focusing on aggressively closing out recently-let contracts...and recouping outstanding obligations before those funds expire...and then re-purposing the funds. The first year they waged this campaign, they saved \$35 million...or rather, stretched their budget an extra \$35 million.

Efficiencies in managing obligations – and increasing buying power – are available to every command! And that's the essence of public stewardship, isn't it? Stretching the taxpayer's dollar...

So, thanks for inviting me today...and allowing me to share with you some aspects of the Department's journey toward financial statement auditability. And, now, when your bar conversation turns to auditability...which I'm sure it will...you'll be able to explain to your drinking buddy...the value proposition for these audit efforts!

ASMC Chapter Essay Contest

The current topic for 2016 Essay Competition is “Identifying and adopting best practices can improve performance. Describe best practices from your career that may improve DOD financial management.” Essays must be original and must not exceed 1,500 words. Dual- or group-authored essays will not be accepted. No member will be permitted to be a repeat winner for more than 2 consecutive years.

Essays will be judged on adherence to topic (how well does the essay meet the contest topic), clarity and readability (how well does the essay flow and is it understandable), content (is the essay original and does it contain substantial content) and general administration (length, grammar, spelling, sentence structure, punctuation). Winners will receive email notification by 1 May and results will be posted on the National ASMC website.

National winners of the Essay Award may have their essays published in the Armed Forces Comptroller magazine and/or the ASMC website. Up to three winners will be selected each year from qualified essays. The first place winner receives \$750; second place receives \$500; and third place receives \$250. In addition, all winners receive a plaque, which is presented at the ASMC Professional Development Institute (PDI). OMB Mid-Session Review projects improvement in new-term budget deficit

Thursday, November 5th, 2015

Today the House passed by a wide margin (370-58) a revised FY2016 National Defense Authorization bill that meets the parameters set out in the [budget agreement](#).

The revised bill aligns FY2016 defense funding with the agreement by [adjusting the total DoD amount](#) downward by \$5 billion.

The new bill provides almost \$607 billion including about \$580 billion for total DoD, \$18.6 billion for the Department of Energy (DoE) nuclear weapons program and \$7.6 billion to meet the statutory requirements for DoD Concurrent Receipt payments.

The new bill cuts added amounts in the [original bill](#) by almost \$1 billion, including \$250 million for Army readiness, \$192.5 million for Army National Guard readiness, and \$150 million for the DDG-51, and \$100 million for PAC-3 Missile Segment Enhancement. The bill also increase cuts made in the original by over \$700 million including \$455 million more for planned DoD headquarters streamlining.

Additional reductions of \$855 million include \$262.5 million for Army civilian hiring targets, \$100 million to classified programs, \$90.1 million for unjustified growth in the Defense Information System Network, and \$50 million for reduced THAAD purchases. The bill also increases cuts to fuel purchases by \$1.1 million due to lower fuel prices.

The revised bill also reduces Overseas Contingency Operations (OCO) funding by \$782 million, including a \$250 million cut to the Counterterrorism Partnership Fund, \$100 million to coalition support, and \$125million to the Syria train and equip program.

No other changes were made to the original bill. It still includes a 1.3 percent military pay raise, reforms to military compensation and retirement, and significant reforms to defense acquisition.

The House-passed bill still contains a provision that prevents the transfer of prisoners from Guantanamo. The White House had identified this provision as a reason for a veto threat of the earlier bill. In a [press conference White House Press Secretary John Earnest](#) did not rule out a possible veto of this bill because of the Guantanamo language, but did say that in any case the president was moving forward with a plan of action to close the prison.

The Bipartisan Budget Act of 2015 and its Implications

President Obama signed the Bipartisan Budget Act of 2015 into law on November 2, 2015. The legislation raises the federal debt limit and establishes the framework for a two-year budget deal.

Over the last 2 weeks, the Department's leadership and many analysts have been scrambling to assess the impacts of the legislation. There are many more steps involved in finalizing its impact and implementing the changes needed to achieve and executable budget but, to start, here are a few things you might want to know about what the act does and does not do.

The BBA15, as it is called, authorizes additional funds for national defense and non-defense equally. It adds \$25 billion to each in FY 2016 and \$15 billion each in FY 2017. Like the Murray-Ryan agreement before it, the BBA15 removes the threat of default to the sequestration levels of the federal budget for 2 years, thus providing the near-term topline predictability that the Department's senior leadership has requested. It also provides relief and establishes funding targets for the Department's Overseas Contingency Operations (OCO) requirements in both years. There is an impact to the relationship between the Department's base funding and its OCO request that the Department is assessing at this time in consultation with the Office of Management and Budget.

It is equally important to recognize what the BBA15 does NOT do. The Act is not an appropriations bill so it does not provide any actual funding for either FY 2016 or FY 2017. Further, it does not prevent a government shutdown either in December 2015 or in the fall of 2016. As a 2-year agreement, it does not change the existing sequestration law for subsequent years and, in fact, sequestration will return in FY 2018 without subsequent legislation. Conversely, neither does it extend sequestration's spending cap limitations beyond FY 2021.

The BBA15 establishes the Department's FY 2016 funding at a level about \$5 billion below the President's Budget request. Senior leaders across the Department are now working out how to take the reduction, with an eye to both its immediate impacts and its implications for the FY 2017 (and outyears) budget request. Meantime, the congressional appropriations committees are working to make the final FY 2016 funding decisions.
