## WATER CONSERVATION NOTICE

Even though we received some measurable rainfall recently, our North Coast region is currently in a state of drought. The District encourages Shelter Cove residents, businesses, and visitors to take action to reduce unnecessary water use and also save any rain water for garden use by installing a roof top catchment system. Small actions by many can be very effective in counteracting water shortages and avoiding the need to mandate conservation measures later this summer.

#### **Utility Pole and Meter Maintenance:**

The District would like to remind property owners who have agreed to maintain the area around power poles to clear away vegetation in readiness for the fire season. We are also requesting customers clear vegetation from around their meters.

#### **CHIPPER DAYS RETURN!**

The District is pleased to announce the return of the chipper program. The first Chipper Day of the season will be on **Saturday, May 28th** with more chipper days planned through the summer. Please take advantage of chipping days by moving your woody material to the roadside's edge with cut butts facing out. Please do not stack limbs over 3 feet high – just start a new pile. Tree trunks over 6" in diameter, stumps, rotten wood, rocks, and garbage will not be chipped.

Contact Shelter Cove Fire at 986-7507 or scfd@sheltercove-ca.gov and let us know when your pile(s) is ready to be chipped. Please complete a Chipper Request Form and document your efforts by using the Firewise Volunteer Hourly Work Sheet both of which can be downloaded from our website or picked up from our office.

Please return the completed forms to our office so the data can be included in the annual Firewise Recognition renewal. Being recognized as a Firewise Community reduces fire insurance costs for homeowners. You can also download a Shelter Cove Firewise certificate from the District's website to provide to your home insurer.

# **Greenbelt Encroachment Permits:**

Residents can obtain (or renew) a Greenbelt Encroachment Permit from the District office to trim trees in greenbelt areas immediately adjacent to their home properties. There is a limited time to accomplish tree trimming and the proper (permitted) burning of the slash as drier summer weather is on the horizon. If you have an interest in trimming the trees in greenbelt areas immediately adjacent to your home, please come to the District office to obtain a Greenbelt Encroachment Permit. We greatly appreciate the community's vegetation clearing endeavors on greenbelt property.
