**TEEN SEGMENT I PROVISIONS**

1. C & C Driving School LLC, will provide a minimum of 24 hours of classroom instruction, 6 hours of behind-the-wheel (BTW) instruction and 4 hours of observation time with a certified Michigan Driver Education Instructor.
2. Classroom instruction must be a minimum of 3 weeks in length and shall not exceed 2 hours per day. Behind the wheel instruction shall not begin until the student has received a minimum of 4 hours of classroom instruction and must be completed no later than 3 weeks after the classroom instruction has been completed.
3. C & C Driving School, LLC. will conduct the BTW instruction in a dual-controlled automobile that is insured by the Provider to cover each student enrolled in the program.
4. **The Student must be at least 14-years and 8-months of age by the first day of a Segment I course. Verification by birth certificate is required.**

**TEEN SEGMENT I TERMS**

1. The parent or guardian agrees to pay the amount of **\$460 when paying by check/money order/cash or \$470 when paying by credit** which needs to be paid in full before class begins. Checks and money orders should be made payable to C & C Driving School and mailed to the address above. Returned checks from a lending institution will be charged \$40 NSF fee.
2. No payment plan will be offered.

4. Also include a copy of **student's birth certificate** to verify age.
5. Birth certificate and copy of completed contract will be returned to parent/guardian.
6. **Class makeup time.** If student misses any class time, they will be required to make up the same class session that they missed (e.g., The student missed day 5 they must attend day 5 of the next available segment I course.)

7. **BTW** make-up policy. If a student misses a scheduled drive they must contact either the classroom instructor or the driving instructor they had the missed scheduled drive with to reschedule the drive.

### **REQUIREMENTS TO PASS THE COURSE**

1. The student will be allowed up to **three attempts to pass the State Knowledge Test** with a score of at least 70%. If the student fails the test after three attempts, they must retake the class at a cost of \$225.00
2. **Required attendance** (24 hours of classroom hours, road- 6 hours/4 hours' observation time) per State of Michigan requirements.
3. The Student must pass ALL BTW Performance Objectives, per the Driver Education Provider and Instructor Act (DEPIA), at the instructor's professional discretion with a satisfactory or higher grade.

### **REFUND POLICY**

If for any reason you decide to withdraw from the course before its completion, your refund will be based on the following.

1. A full refund minus a \$25 administrative fee will be issued if the student withdraws from the class prior to the start of the first classroom session.
2. Before the beginning of the third-class session, 80% of the total tuition will be refunded if no BTW instruction was given. If drives were completed \$25 will be deducted for each drive.
3. After the third class no refund given.

## Appendix #1

### Pink Permit Information

Pink slips allow driver's education students to drive with a parent or legal guardian while taking a driver's education class. The following rules apply:

Students can only drive where they have been with an instructor.

Drive 1-Residential streets up to 40 MPH.

Drive 2-Rural highways up to 55 MPH.

Drive 3-Suburban Driving

Drive 4-Urban/City Driving

Drive 5-Freeway/Expressway Driving

Drive 6-Final evaluation drive.

1. Students may not drive out of state on a Pink permit.
2. If you wish your child drive with another adult 21 years or older, they must be licensed in Michigan and insured in Michigan. You must give them written permission and always keep this in the car.

3. Like a regular license, the Pink permit should be with your child whenever they drive. If lost or destroyed ask classroom instructor for a new one.
4. Student can drive at night with a Pink permit.
5. Parents, be sure to contact your insurance company to determine whether a change to your car insurance policy is required prior to using the permit.
6. Pink permits will be collected on the last day of class.

## Appendix #2 Additional Classroom Rules

1. Students are NOT allowed to be anywhere in the school building except the immediate hallway, restroom, and classroom areas without the approval of the classroom instructor.
2. Any damage done by a student to the Blended Learning Academies property, buildings, or grounds will result in the student being immediately dropped from the class with NO refund given. Any payment necessary for the damage will be the responsibility of the student and/or parent. Criminal activity will be reported to local authorities and the student's parent/guardian.
3. Restroom use will be limited to before class unless it's an emergency.
4. Students are responsible for having their class materials brought to every class.
5. Please no open toe shoes when driving.
6. Any student suspected of being under the influence of alcohol or drugs during class or while driving may/will be dismissed from the program and their parent/guardian will be notified. If necessary, local law enforcement officials will be notified. No refund given.
7. Please no food, beverages, or gum allowed in class or while driving.
8. Students are expected to pay attention during class and on their drives. Excessive talking either in class or while driving could impact their passing the test and the class.
9. No electronic devices may be used in or during class or in the car unless approved by the instructor. Phones must be turned off and stored away if brought to the classroom. The instructor may request all phones be collected before class begins.
10. Sleeping in class or working on other activities while in class could result in student being considered absent and must make the time up.
11. The instructor retains the authority to make a seating chart or ask students to sit in certain seats during the class.
12. Attitude and maturity are an important part of driver's education and of teenage driving. There are always risks when teaching new drivers, the consequences are too great to have immature teenagers behind the wheel with other students and instructors in the car.
