Current Budget

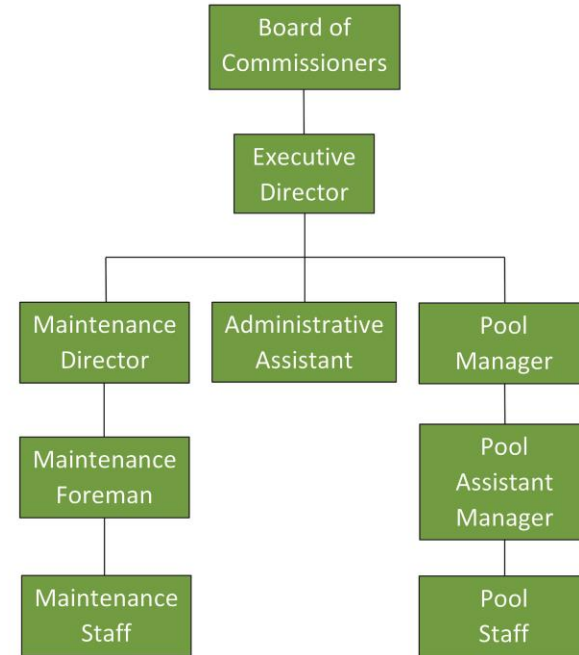
The operating budget for FY2022 is \$796,936.87. The fiscal year begins July 1, 2021 and ends June 30, 2022.

Staff

The Park District has an appointed Executive Director responsible for the administration of the Park District. The Park District employs 5 full-time staff. During peak season, the HTPD employs an additional 25 temporary/seasonal workers to provide the needed support for park operations and recreation programs.
