

North Louisiana Criminalistics Laboratory Internship Application

The North Louisiana Criminalistics Laboratory (NLCL) internship program allows rising college seniors and graduate students an opportunity to complete a project using techniques routinely performed at a forensic laboratory in the firearms, forensic biology, forensic chemistry, and forensic toxicology sections. Typically, an intern will work on a project in a specific discipline but will have the opportunity to shadow qualified analysts in other sections. The duration of the unpaid internship is typically 8 to 12 weeks with a minimum of 20 hours per week being spent in the laboratory.

While at the NLCL, the intern is required to obey the rules and regulations of the laboratory, which will include a background check and a drug screen. Qualified candidates must be U.S. citizens and permanent residents who are eligible to work in the United States.

The following documents must be appended to this application: | Internship Application | Curriculum Vitae | Letter of Recommendation from advisor | Letter of liability insurance coverage by the University | Unofficial transcripts | Tentative schedule of availability After the application is received by the NLCL, an interview will be scheduled prior to acceptance, which may be done in-person or over the phone. Once accepted in the program, the intern must sign a confidentiality agreement form prior to

beginning the internship. Additionally, interns are not employees of the laboratory and may not represent themselves as an employee of the lab.
