FULL-TIME JOB VACANCIES

Full-time benefits package includes paid vacation, sick, CalPERS retirement, medical, dental, vision and life insurance. Applications and job postings are available at the RID office and website. Vacancies open until filled.

Industrial Electrician and Instrument Technician:

Minimum qualifications: High school graduate, valid, clean DMV record and previous experience with Community College, technical or other relevant course work. Must pass a pre-employment physical and drug screen required. Must live within 1 hour traveling time to Shelter Cove.

Desired qualifications: 3-5 years of journey-level experience in electrical and electronic construction, repair and maintenance, preferably with some direct experience at a water/wastewater treatment plant or similar facilities.

Salary: Compensation range \$24.55 to \$45.87 BOE.

Wastewater Treatment Plant Operator Grade 1 or 2:

Minimum Qualifications: Must possess a valid Grade 2 Wastewater Treatment Plant Operator Certificate issued by California SWRCB. 2 years of experience working in a wastewater laboratory and wastewater treatment plant operation; Must pass a drug and alcohol screening and physical exam. Must possess a valid California driver's license and live within 1-hour traveling time to Shelter Cove.

Desired Qualifications: 1 year of experience in the operation of domestic water treatment and distribution.

Salary: Compensation range \$19.55 to \$40.98 BOE.

General Laborer:

Minimum Qualifications: High school graduate. Must be computer and network/internet literate. Should have the ability to understand and carry out oral and written direction, and maintain cooperative and professional relations with the public at all times. Should be organized and accurate with a solid understanding of basic English, simple bookkeeping practices and math at a level required for successful job performance. Must have 1 year of experience in general construction work, or equivalent. Must live within 1 hour traveling time to Shelter Cove. Must possess a valid California driver's license. Passing a pre-employment physical and drug screen required.

Salary: Compensation range \$14.34 to \$23.76. BOE.

Journeyman Lineman:

Minimum Qualifications: High school graduate. Must have completed an accredited 4-year apprenticeship program and have 4 years Journeyman line experience.

Under general supervision, perform experienced level work in the construction and maintenance of overhead and underground electrical lines and electrical distribution system, and perform related duties. Must live within 1 hour traveling time to Shelter Cove. Must possess a valid California Class A driver's license. Passing a pre-employment physical and drug screen required.

Salary: Compensation range \$37.06 to \$54.01 BOE.

WATER TANK CONSTRUCTION UPDATE

Significant progress has been made on the first phase of the tank project by the on-site contractor G.R. Sundberg. The three tanks that are scheduled to be replaced this year have been demolished, temporary water bypasses have been installed and cement foundations are complete, and the project is moving along nicely. The District did receive one noise complaint when demolition was underway so moving forward we will try to warn neighbors ahead of time of noisy work that may impact them. Construction work times are limited to the following hours: 7:30 a.m. to 6 p.m. on weekdays and 9 a.m. to 6 p.m. on weekends.
