- 4. Principal's report: Jenny Lynch
 - a. It feels good to be back to school after the wildfires. There has been a shift in direction. 13 Austin Creek Families have lost homes. The general student body has been affected in several ways lots of fear and anxiety being seen among the students. Staff are working through the issues and helping those affected.
 - b. Kinder table update: Considering putting the tables elsewhere because in order to move the wood chips the area needs to be repayed.
 - c. Questions by Katherine Larson: How can we help the AC families who have lost homes? Answer by Jenny Lynch: most of the families have found some sort of temporary housing. Prior to fires the district had a 1% housing issue now we have lost 5% of our homes in Santa Rosa. Looking at a 2 to 4 year re-build. This will be a long-term recovery and we need to patient with how to help. The needs will come with time.
 - d. Expecting new registrants from other schools where students have been displaced and deemed "homeless." New registrants can enter a grade at AC that has space. Otherwise, Rincon Valley District will

- accept a student and place that student where there is space in the district.
- e. Looking into helping a significantly affected school Riebli and Shafer. Waiting to hear back from those schools as to what their needs are.
- f. Principal Lynch is checking air quality daily prior to AC students going out to recess. Masks are available in the office if parents/students would like one.
- g. HEPA filters are running over night to keep the classrooms clean.
