





BARS E-BAY SALES AND AUCTION SALES OF SURPLUSSED EQUIPMENT

The BARS Board of Directors has adopted a method for the disposal of all items in our donated equipment inventory through the transfer of ownership by making them available for purchase by open public auctions and sales. We have determined that it is to the optimum benefit of BARS that we try to obtain the maximum amount for each item, or related sets of items, by accepting only the highest value received through as fair, and as equitable, and as impartial a public process as reasonably possible. In this way we endeavor to eliminate any impressions of advantage or disadvantage to anyone or group wishing to obtain by purchase any item or items.

Our process in operation now is to periodically, and more-or-less continuously, move a somewhat small and easily manageable group of equipments, selected to some extent at random, from a storage facility to the BARS room at the Red Cross Building. At the BARS room, the equipment is basically evaluated (maybe even "smoke" tested) to determine a reasonably accurate and reliable description of its condition. Any equipments that we envision may be of utility to the Club are retained for use in the shack or the shop. Those items that are marked for sale through E-Bay are weighed and photographed, and then researched in an effort to determine their histories and current comparative values. After that, the equipment's descriptive file, including our asked and reserve price, is up-loaded to the E-Bay sales website under our "Bluegrassars" account to make our intentions universally known that the equipment is publically available by timed auction or instant fixed-price purchase. In this way we are trying to keep up a simple uninterrupted cycle of listings, purchases, and shipments which will eventually deplete our inventory of donated and surplus items and eliminate our need and the expense for a rented storage facility.

The current (and previous) BARS Bylaws in its Preamble is specific in its intention that "*No part of the resources, and/or property, and /or net earnings of the corporation, if any, shall inure to the individual benefit of, or be distributed to, any of its members, trustees, directors, officers, or other private persons…"*. In order to insure our own compliance with our own rules, no offers for purchase of any Club owned items will be considered that are not conducted in an open public venue or setting by the methods currently adopted by BARS. This prevents any perception of preference to any purchaser, including Club members, and provides an element of assurance that the Club realizes a monetary amount that was determined by as fair a market demand value attainable at the time of the sale. We generally consider this approach is of the overall advantage to BARS, its members, as well as any others involved in these types of financial transactions with the Club. In addition, the Club has established a reputation through E-Bay of reliable and highly-rated service which has allowed us to increase our listings due to our so-far proven credibility. The Club intends to maintain this commendable level of association with E-Bay as our outlet for sales of our major surplus'd electronics equipment.

There is a prior knowledge of the items that will be coming to sale by some of the Club members who assist and help with the moving from the storage unit to the BARS room. During the interim period between transporting, preparation, and posting for sale on E-Bay, the items are normally "on display" in the BARS room except for those of exceptional condition and value that are securely stored away to prevent damage or theft. Also, once an item is posted on E-Bay and before its final sale, it is available by appointment for a hands-on, non-destructive, inspection by anyone interested in attaining the item only through the E-Bay venue. The E-Bay sale amount transaction includes the final accepted item price, plus applicable sales tax and estimated shipping costs based on weight and method, that will all be paid by the buyer. The Club receives a net amount after E-Bay listing fees and financial transaction fees are deducted. The difference between the E-Bay assessed and the Club's actual shipping costs are subsequently reconciled by BARS. A local or nearby buyer can forego the E-Bay determined shipping costs by opting for a local in-person pick-up arrangement scheduled at the BARS room with proper purchase confirmation paperwork.

Minor items and equipments that have been judged and determined to be of relatively low nominal value and demand and that probably will not be successfully sold on E-Bay, have been set aside for simpler disposal but still by fair public sales methods. Various assortments of the Club's recently attained donated and then surplus'd items have been sold at the silent auctions conducted at our Hamfests in 2019 and 2018, where the Club deducted the applicable sales tax from the winning bid price rather than add the sales tax on to the buyers cost. A pleasant situation occurred recently when one, if not two, hamfest attendees offered a one-price, take-it-or-leave-it-right-now, amount for some equipment before the close of the silent auction. We could not in good conscience change the rules in fairness to those who had and would be actively bidding on the same item(s). The prospective purchaser was encouraged to place his bid on the auction sheet (with a contact number) as others had, and then see how the offers proceeded. At the end of the auction, the winning bid was from the "one-price" buyer whose unbeaten offer was less than the on-the-spot price he originally proposed. Should BARS have held him to his first bargain? The Club retained its honor and reputation, and our patron retained the difference in his wallet.

The decision of the Board of Directors to respectfully not accept offers for privately arranged purchases of BARS property reflects our position to consider the best interests of BARS and its members and other stakeholders who rely on the Club as an organization to operate with the knowledge of all concerned constituents in an open and visible, even if less than an expedient and seemingly unaccommodating, unbiased and objective manner.

The Board of Directors have decided that the Ernie Farmer Award would be suspended for the year of 2020. This is due to limited activity and contact with the public and other Amateur Radio operators.



Emergency Communications Driving Increase in Amateur Radio Operators...

Hams standing by and ready to help during disasters or other events.

More Americans than ever have been licensed by the Federal Communications Commission as amateur radio operators, and those in the know say that emergency communications is driving their passion to be "hams." "There has been a tremendous amount of interest in emergency preparedness since 9/11 and Katrina, and this is true for the amateur radio community as well," said Mike Corey, the emergency preparedness manager for the American Radio Relay League (ARRL). "Emergency communications is a gateway into amateur radio, and many join our ranks through an interest in being better prepared themselves and as a way to serve their community."

"This is the third year in a row that the total number of new licenses has exceeded 30,000," said ARRL Volunteer Examiner Coordinator Manager Maria Somma last year. She said 32,552 were granted in 2016, 32,077 in 2015, and 33,241 in 2014. Total active FCC-issued ham radio licenses hit an all-time high of 743,003 in November 2016.

The public's growing interest in amateur radio for emergency communications is a legacy of 9/11, when Americans saw their cellular telephone networks become overwhelmed by excess traffic and system outages. When regular phone service fails, amateur radio operators fill the communications gap with their independent transceivers and battery power backups.

"I think we have experienced an uptick in new licenses due to the emergency capabilities of ham radio," said Jack Ciaccia, ARRL Colorado section manager. "Interest really peaks after a large-scale event where ham radio has been utilized."

Remotely Administered Amateur Exam Systems Showing Promise

Facing a growing demand for amateur radio exam sessions in a time of social distancing and stay-at-home orders, sponsors of some Volunteer Examiner (VE) teams have risen to the challenge and are developing systems to remotely proctor test sessions.

"Many of our VEs and VE Teams have been working on remotely proctored exam session ideas, employing both video and in-person components — following social distancing protocols," ARRL Volunteer Examiner Coordinator (VEC) Manager Maria Somma, AB1FM, said. "We have been receiving interesting and innovative suggestions, and we appreciate the dedication and ingenuity our examiners have shown."

The Spalding County Amateur Radio Club in Georgia is among those that have come up with plans to remotely administer amateur exams while complying with ARRL VEC testing standards during COVID19- stay-home mandates and social distancing guidelines. Current systems leverage Zoom video-teleconferencing technology, the "Fill & Sign" feature of Adobe PDFs, reliable email, appropriate computer equipment and internet connection, and no volunteer examiners (VEs) present at individual remote test sites. The Georgia club collaborated and shared ideas with the Emergency Amateur Radio Club (EARC) in Hawaii, which has successfully conducted sessions since 2011 with its own remote testing system, initially with paper exams with a proctor on site and now with fillable PDFs, with no on-site proctor.

The Georgia club obtained ARRL VEC approval to administer video-supervised exams. The club's David Robinson, K4WVZ, said the first exam session took place this week, with another set for next week, and "many more in the pipeline" going forward.

"We have started with testing just one candidate at a time but are planning to ramp up to multiple candidates — probably two or three — simultaneously," Robinson told ARRL. "Before we do that, we want a few more single sessions under our belt and a few more Video VEs trained. It also gives us an opportunity to garner lessons learned from each test session and upgrade our procedures accordingly." Robinson said this week's session went "exceedingly well," and the candidate passed the test.

The club's procedures entail a pre-exam video interview with candidates to ensure they understand all the requirements and procedures. "This also allows us to test the candidate's ability to work with the video and computer technology before the actual exam," Robinson explained. "Training sessions were conducted for VEs to make sure they understood their role and how to use the technology."

Following the exam, the VEs score the test and sign off on the paperwork, with the VE Team Leader submitting the application online and by mail, per ARRL VEC instructions. Application and successful exam are first accepted and then submitted to the FCC for processing.

New England Amateur Radio Inc (NE1AR), an affiliate of New England Sci-Tech, (NESciTech), has taken it one step further, Somma said. It got the approval of ARRL VEC to begin trials of what it describes as "completely online testing with strict rules and protocols for maintaining the integrity of the testing environment." NE1AR is limiting candidates to one exam per candidate, due to the current candidate backlog and the "difficulty of administering exams online." Candidates must agree to a list of protocols, which include no visitors (or pets) in the exam room and a cell-phone camera scan of the entire room and exam area "to show that there are no materials or people [in the room] that could aid in taking the exam." If the VE team suspects the possibility of cheating, the exam may be terminated and the candidate barred from future online exam sessions.

"We began a series of trials on April 1 under ARRL VEC review and have now been asked to help train more VE Teams on the process," NE1AR President Bob Phinney, K5TEC, told ARRL. "We have now tested 12 applicants and are still working on streamlining the process. We are working with the software developer of the exam delivery system to help them adapt the system for video-supervised testing." At present, Phinney said, only one person at a time can be tested. Another time-related issue is how long it takes a candidate to go through the NE1AR security protocol. "Sometimes, the setup and follow-up for an exam take far longer than the exam itself, in order that we provide complete integrity of the exam session," he said.

With pressure continuing to build to provide testing compatible with COVID-19 guidelines and stay-home orders, ARRL VEC Manager Maria Somma, AB1FM, has asked the amateur radio community to be patient. "Please remember that with the introduction of significant new processes such as these, that there should be proof of concept, establishment of protocols and procedures, and beta testing, before expanding to a larger audience," she said this week. Somma said video-supervised exam sessions require a different skillset than in-person exam administration, and not all teams will be equipped to deliver video exams right away.

"ARRL is pleased to be one of the leaders in providing an opportunity, although limited initially, for video-supervised exams in this time of social distancing and isolation required by the current health situation," Somma said.

Amateur radio operators played a substantial role in restoring vital communications links in the wake of 9/11, hurricanes, tornadoes and other major disasters that have affected the United States. They assist in directing first responders to victims, providing real-time situational updates from the disaster scene to emergency management agencies, and offering victims a way to contact their families and friends when normal communications channels have failed.

"Generally, amateur radio operators assist other organizations and agencies by adding communications capacity when normal means of communications are down or overloaded," Corey said. "Amateurs work with local emergency management, first responders, hospitals, National Weather Service, National Hurricane Center and VOADs [Voluntary Organizations Active in Disasters] and the Red Cross and Salvation Army. Many also use amateur radio as part of their own family communications plan and use the skills they learn as amateurs to assist neighbors during emergencies and disasters."

Walt Palmer is a licensed ham radio operator, and also director of broadcast operations, engineering and programming at NewsRadio WGMD 92.7 FM in Rehoboth Beach, Del. "Through an arrangement with our local EOC, I have a 2-meter ham radio set and antenna at my desk, which can be patched into our FM transmitter during emergencies," he said. "If regular communications fail, the EOC can put the mayor or one of their officials on the 2-meter band, and I can rebroadcast it via our FM channel to our entire coverage area."

Emergency managers have taken note the usefulness of amateur radio operators during manmade and natural disasters — and many have ongoing relationships with their local ham communities. This includes assigning amateur radio operators specific roles within each agency's emergency response plan, and even setting space aside for hams in their EOCs.

For many years, ARRL has created special Amateur Radio Emergency Service (ARES) units to assist during times of crisis. Each ARES unit "consists of licensed amateurs who have voluntarily registered their qualifications and equipment with their local ARES leadership for communications duty in the public service when disaster strikes," according to the ARRL website. ARES members are trained to work with local emergency management; to have their own food, sleeping equipment and other supplies to survive during emergency situations away from home; and to have pre-planned for their families' well-being during the ARES team member's absence.

"In most cases, the amateur radio response to an emergency or disaster is handled by local ARES teams," said Corey. "However, in the case of large-scale disasters such as a large hurricane or earthquake, ARRL headquarters will assist local and state ARES teams with equipment, media support, regulatory guidance and coordination with national partners."

"Most of our ARES teams around the country partner with local and state emergency management," he added. "In most cases this relationship also allows for closer work with other local response groups such as public safety, hospitals and local VOADs."

This is certainly the case in Colorado. In 2016, the state Legislature officially designated qualified hams as members of Colorado's new Auxiliary Emergency Communications Unit, under the authority of the state's Division of Homeland Security and Emergency Management, in the Department of Public Safety.

As a result of this new law, Colorado ARES teams are now part of their state's emergency management team, with their own roles with their state's emergency management plans and facilities.

"In many EOCs, including the Colorado EOC, ARES has its own space with its own permanently installed radio gear and antenna installations," Ciaccia said. "In Boulder, they also maintain a cache of portable equipment that can be deployed as soon as manpower is available. This way, they never have to worry about obtaining anyone's personal gear for use in an emergency."


It is worth noting that hams also aid emergency managers in less dire situations. For instance, "throughout the United States, amateurs assist the National Weather Service's SKYWARN program in providing ground truth reports during severe weather events," Corey said. All told, the growing number of amateur radio operators in the U.S. are self-funding, fully equipped communicators, many of whom want to support local emergency managers and first responders any way they can.

"We have worked extremely hard over the years to become useful and professional with our assistance to our community OEMs and EOCs," Ciaccia said. "The major capability that hams bring to emergency management is our varied modes and frequencies: We can usually make a communications path when others do not exist. Because of those two important and valuable commodities that are usually not available to public service entities, we are an important asset to local authorities in times of need."
