Tax Updates

Things to know >>>

Virtual currency is a top question! The IRS wants to know if you received, sold, or exchanged any virtual currency. All sales should be reported as capital gains. If a hard fork happens and you received new crypto, this is taxable income!

Medical expenses that exceed 7.5% of the AGI can be itemized. Medical mileage is 16 cents.

Monetary charity donations up to \$600 MFJ or \$300 for all other returns can be deducted without itemizing. Charity mileage is 14 cents.

A new 1099K for 2022 will come to those individuals that have more than \$600 in payments from third parties for the provision of goods or services such as ebay, paypal, etsy, etc. If this effects you, you may want to bring it up in your tax consultation!

100% deduction for business meals for 2021 and 2022, with limitations of course.

The 3rd stimulus payment of generally \$1400 came out at the beginning of 2021. We will need to know what you received to reconcile your amount to your tax return.

There are still piles of returns waiting to be processed at the IRS so patience will have to be a virtue!

American Rescue Plan

Child and Dependent Care Credits

The American Rescue Plan Act (ARPA), enacted in March 2021, changed a few limits in relations to the credits for children. Dependent Care Credit and Child Tax Credit both increased and became fully refundable for 2021 only with income limitations.

The child tax for the tax year of 2021 is \$3000 per child under age 18 or \$3600 per child under age 6. This credit is fully refundable for 2021 only. It is phased-out with income levels above \$75k for Single taxpayers, \$112k for Head of Household and \$150k for Married Filing Joint Taxpayers. As we all know this year, the IRS was paying 50% of this credit in advance starting in July. This, Advance Child Tax Credit, as we call it are early payments from the IRS based on 50 percent of the estimated amount of the Child Tax Credit that they expect you to properly claim on your 2021 tax return during the 2022 tax filing season. If the IRS had processed your 2020 tax return, these monthly payments started in July and went through December 2021, based on that information. If you opted out of the advance, you can claim the full credit on your 2021 tax return when you file your return. If you took the advance, you will need bring form 6419

And we will have to reconcile the amount received early with the amount that you are entitled to based on income from this year as well as dependents being claimed this year. Your advance will not be taxable to you, however, if you received too much based on what you were allowed, you may have to pay back the advance if you no longer qualify for the anticipated amount. Some may qualify for repayment protection based on Modified Gross income. This means, to not repay any advance back, your income for a Single filer must be below \$40k, \$50k for Head of Household and \$60k for Married Filing Joint. The child tax credit this filing year can be claimed even if you have zero taxable income! So, even filers with dependents that normally don't file could file and get a return. Dependent Care Credit also has an increase this year to \$8000 per child for child care or \$16000 total for two or more children. This credit is refundable and based on income as well.
