

Crossroads' goal is to decrease the risk of misdemeanor Violation of State Firearm Act (VSFA) escalating to homicides!

In Alabama, hundreds of people each year die in gun-related homicides, suicides and accidents, according to information from the Alabama Department of Public Health.

97 homicides were reported in the city in 2015

63 homicides were reported in the city in 2014

70 homicides were reported in the city in 2013

77 homicides were reported in the city in 2012

63 homicides were reported in the city in $\frac{2011}{}$

64 homicides were reported in the city in 2010
