CONNECTION FEE CHANGE DISCUSSION

At the January 17, 2020 meeting the board will continue discussion regarding preliminary adjustments to utility connection fees. The public is encouraged to attend and provide comments.

HIGH SURF ADVISORY

During our pacific winter weather cycle, large ocean



swells, generated from southerly storms, impact Shelter Cove's shoreline. People should exercise the following precautions when high surf conditions are present:

- Never turn your back on the ocean.
- Stay further back from the water than usual, avoiding salt spray.
- Stay off the jetty and rocks.
- Stay out of the water as sleeper waves and strong rip-tides appear along the coastline.

FIRE DEPARTMENT NEWS

Air Quality Management District Burn Permits:

New AQMD burn permit applications for 2020 are available at the District Office or from the Fire Department. After mailing off the application and a \$20 check for the fee for a Standard Burn Permit, it takes about a week for your permit to come in the mail. You can also apply online at <http://www.ncuaqmd.org/index.php?page=burn.permits> Your permit will be emailed to you.

You can obtain a permit directly from the AQMD office located at 707 L Street, Eureka - Monday - Friday from 9:00a.m.-12:00p.m. and from 1:00p.m. - 4:00p.m.

Once you have a valid permit please call 1-866-287-6329 to get the burn-day status for coastal zone 1 after 5 p.m. the day before you plan to burn. Please follow directions on your permit, keep burn piles small and refrain from burning on windy days. Please be aware that our fire department does not set the status of burn days, AQMD determines burn days based solely on air quality and local burning conditions.
