




1. The meeting was called to order at 7:15 PM at the Harrisburg Park Office.

6. President's Report
  - Financial Review - \$31,200.10 balance in the account.
    - Blake went over all the receipts and expenses for June.

  - 12U Boys Travel Team Incident – There was a coach incident at the game against Galatia. It was isolated. The coaches got heated and lost it. Blake handled the situation even after it blew up on Facebook.
  - Fundraiser – Steward Chiropractic is hosting on July 28 as Patient Appreciation Day.
  - SYSA Scheduling Meeting – July 12 at 7PM – meeting to go over schedules. Will have to use Shaw St some this year for practices because the area behind Jehovah Church will not be ready.

  - 2022 Baseball/Softball Season – feedback we heard was this it needs to be more competitive. Will brainstorm over the next couple of months on how we can do this. 9U Level it was talked to limit to 2 innings in one game for pitchers.
  - 2023 Baseball/Softball Travel Teams – Have to play the rec league to travel. This worked great for 12U boys this year. Do not have to be from Harrisburg. Local Travel with single/double header games. Damian made the motion to have a team for each league for 2023 season and Kyle seconded. Motion carried 9-0. Blake will get an announcement out this week. This will be for Boys and Girls 10U and 12U Leagues. We had one coach from PowerAlley call to see if HYA would sponsor their team for the Route 13 League. It was discussed and Evan made the motion not to sponsor a non-HYA travel team in another league and seconded by Damian. Motion carried 9-0. It was discussed to potentially offer and 14U travel team for the Route 13 League. Evan made the motion to potentially have a team at this level and seconded by Damian. Motion carried 9-0.
