8. New Business

- 2022 Baseball/Softball
 - Field Duty Blake mentioned that there won't be a Field Duty schedule, rather if a Board Member is present at the fields and an issue come up they be willing to help out.
 - Concessions It was discussed, and Matt made the motion that we resume concession stand team tickets like previous years and the kids go up to the concession stand after the game to redeem their items and seconded by Evan. All in favor 6-0.
 - Matt asked a question about a special needs participant and if the rules could be flexed to allow for better participation. Blake mentioned that HYA will always accommodate any special needs participant in any way that we can that will help them have a more joyful experience in the program.
- HYA Travel Teams
