

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.cgcbautycollections.com, and Charlestonhill Global Consulting Services LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Charlestonhill Global Consulting Services LLC include www.cgcbautycollections.com and CgC Beauty Collections. The CgC Beauty Collections website is a ecommerce site. By using the CgC Beauty Collections website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, CgC Beauty Collections may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase CgC Beauty Collections's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

CgC Beauty Collections may also collect anonymous demographic information, which is not unique to you, such as your:

- Gender

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

CgC Beauty Collections collects and uses your personal information to operate and deliver the services you have requested.

CgC Beauty Collections may also use your personally identifiable information to inform you of other products or services available from CgC Beauty Collections and its affiliates.

Sharing Information with Third Parties

CgC Beauty Collections does not sell, rent or lease its customer lists to third parties.

CgC Beauty Collections may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. Automatically Collected Information

- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
