MEETING MINUTES HARRISBURG TOWNSHIP PARK DISTRICT PUBLIC HEARING MEETING SEPTEMBER 17, 2021 8:00 AM HARRISBURG PARK OFFICE



Minutes of a regular public meeting of the Board of Park Commissioners of the Harrisburg Township Park District, Saline County, Illinois, held in the District Office, 921 W. Poplar Street, Harrisburg, Illinois, in said Park District at 8:00 o'clock a.m., on the 17th day of September, 2021.

CALL TO ORDER:

The meeting was called to order by President Richard Rumsey at 8:01 a.m.

ROLL CALL:

Upon the roll being called, Richard Rumsey – the President and the following Park Commissioners, Doug Emery – the Vice President and Mike Williams – the secretary, were physically present at said location 921 W. Poplar Street, Harrisburg, Illinois.

Park Staff Present: Executive Director Blake Emery, Administrative Assistant Jill Marvel, and Maintenance Director TA Sullivan.

Visitors Present: Ron Emery, Tim King (Kings Financial), Brent Flota (Kings Financial)

ANNOUNCEMENT:

The Executive Director announced that the next Agenda item for the Board of Park Commissioners was a Public Hearing (the "Hearing") to receive public comments concerning the intent of the Board of Park Commissioners of the District to sell \$620,000 General Obligation Park Bonds and to receive public comments on the proposed Ordinance 2021-0917 Budget and Appropriation Ordinance for Fiscal Year July 2021 through June 2022 (the "Ordinance"). The meeting was opened for public comments.

BOND:

Potential Projects

Blake Emery presented to the Board a list of potential projects to be completed with the proposed Bond Funds. The list was discussed item by item. The reasons for the proposed issuance of the Bonds were as follows: ADA upgrades, land acquisition, Maintenance equipment, Mulch/Dirt/Turface, Security Cameras, Parking lot upgrades, Trees, Shelter Upgrades, Lighting, Dog Park, Shade Structures, Splashpad, Pool Improvements, Grills, Sport Court Surface, Fencing, Concession Renovation, Bandstand Canopy, Digital Sign, Gaga Ball Pit, and Pond Fountain. Mike Williams asked to consider shade structures over the bleachers at Gaskins City. Richard Rumsey made the motion that the items on the potential projects list will be further discussed and decided upon at subsequent Regular Board Meetings and seconded by Mike Williams. All in favor 3-0 per voice vote.

Public Comments

Written testimony concerning the proposed Budget and Appropriation Ordinance was read into the record by the Executive Director: None

Whereupon the Executive Director asked for oral testimony or any public comments concerning the proposed General Obligation Park Bonds. Statements were made by the following: None

The Executive Director then announced that all persons desiring to be heard have been given an opportunity to present oral and written testimony with respect to the proposed General Obligation Park Bonds.

Bond Funds Needed

Tim King, from Kings Financial, presented the Debt Limitations and Bond History for Harrisburg Township Park District. Current Debt Capacity is \$616,358. It was discussed that the intent is to keep the annual payment consistent with the past few bonds. Richard Rumsey made the motion to issue bonds at \$616,300 with a three year payout and it was seconded by Mike Williams, and approved unanimously with Doug Emery casting the final vote for approval.
