

Motion made, seconded, discussion. One voter asked for Article 2 to be voted on by secret ballot when the time came. Another voter asked for the article to be amended as follows:

Shall the town vote to change the positions of Town Clerk and Tax Collector from elected positions to appointed positions, to be effective upon the expiration of the current terms, or vacancy should that occur prior to end of current elected terms as provided in Title 30-A Section 2525 of the Maine Revised Statutes?

Discussion Continued, one voter asked moderator to move article, moved, seconded. Passed

Moderator asked voters if they were in favor to vote on article by secret ballot at the request of one voter earlier in the meeting.
Motion, Seconded, majority opposed. Failed

Moderator asked voters if they were in favor of Article 2 as amended.
Motion, Seconded, 6 Opposed
Article 2 Passed at amended.
