REQUIRED LANGUAGE

NOTICE- This provider is required to be certified by the Secretary of State. Completion of driver education instruction does not guarantee qualification for a driver license.

1. C & C Driving School, LLC. will provide a minimum of 6 hours of classroom instruction with a certified Michigan Driver Education Instructor. Classroom instruction shall not exceed 2 hours per day.

2. A driving log must be presented to verify that the student has completed a minimum of 30 hours of driving (including 2 hours at night) with a licensed parent/guardian or a designated licensed adult driver 21 or older. A log was presented to the Segment II instructor on or before the first classroom session.

3. The Student must have held a Level 1 license for not less than 3 continuous months.

TERMS

1. The parent or guardian agrees to pay the amount of **\$60.00 check/cash/money order** or **\$65 credit card** which needs to be paid in full by the first day of class. **This course fee does not include Road Test fees.** No Certificate of Completion will be issued until the student has paid in full.
2. Requirements to pass the course: *Students must pass the state test. The required score to pass is 70%.*

3. After successful completion of 6 hours of classroom instruction, the student will be issued a Segment II Certificate of Completion.
4. In case of a student's absence or emergency the school's policy is: Student may miss class only for an illness or emergency with documented proof presented to the instructor. The student is required to make up the same class session missed (The student missed day 2 and must attend day 2 of the next available segment 2 course.). In event of any type of emergency the parent/guardian will be immediately notified by phone.
5. A fee of \$10.00 will be charged for each request for a replacement of a Segment 2 Completion Certificate.

REFUND POLICY

1. After the beginning of the first-class session, NO REFUND shall be given.

Classroom Rules

Student hereby agrees to abide to the classroom rules addressed during the first day of class. Violation of these rules may be grounds for dismissal and forfeiture of any fees paid for the class.

1. Students are NOT allowed to be anywhere in DeWitt High School or Junior High except the immediate hallway, restroom, and classroom areas unless they are part of a school activity before or after the driver's education class.
2. Any damage done by a student to DeWitt school property, buildings, or grounds will result in the student being immediately dropped from the class with NO refund given. Any payment necessary for the damage will be the responsibility of the student and/or parent. Criminal activity will be reported to local authorities and the student's parent/guardian.
3. Restroom use will be limited to before class unless it's an emergency.
4. Students are responsible for having their class materials with them for each class.
5. Any student suspected of being under the influence of alcohol or drugs during class may/will be dismissed from the program and their parent/guardian will be notified. If necessary, local law enforcement officials will be notified. No refund given.
6. Please no food, beverages allowed in class.
7. Students are expected to pay attention during class. Excessive talking in class could impact their passing the test and the class.
8. Attitude and maturity are an important part of driver's education training and teenage driving.
