West Central Idaho Initiative strategy

Funding for the West Central Idaho Initiative (WCII) will likely come in FY2022. The Payette and Boise National Forests have begun discussing the framework they'll use to proceed once funding comes through. Questions for today's discussion include what does that framework look like thus far? How will the PFC work with the two Forests and the Boise Forest Coalition? Who from the PFC will participate in those discussions? Members are encouraged to think about additional topics or questions for discussion and post them on the December meeting Forum thread.

LCBC ruling

In September the Forest and PFC filed a motion asking Judge Winmill to reconsider his decision and permit all activities except commercial timber harvest on MPC 5.2 lands to proceed. That motion has been denied. Lawson Fite will brief the Coalition. The decision has been posted to the PFC website and is in the Project Library under LCBC.

Next steps for Granite Meadows and LCBC

The Granite Meadows timeline has shifted given several factors including how to address LCBC. This will be an overview of a more robust conversation slated for January about how the Forest is thinking of approaching the lack of a decision on activities across the 80,000 acre area formerly within the LCBC project and a request for feedback/input from PFC about those next steps.
