A note from the Pastor...

At our annual meeting on November 17 we faced some significant decisions that affect how we do our ministry together. Perhaps the most surprising decision was to adopt a budget that reduces my position to 80% time.

I am going to set down here some of the things I said at the meeting about this step. First I wanted people to understand that the budgeting committee and council made the recommendation with my full encouragement. We have communicated regularly in recent years about where we stood financially and we have undertaken a couple of financial response efforts in the past few years. In 2017 the households of the congregation increased their giving almost 23%. Since that time, several of our largest supporting households have either died or needed to relocate. When we looked at present and future trends it became apparent to me and our leadership that we needed to reduce our planned expenditure by \$20-30,000. The only realistic way to approach that is to look at how we are paying for staffing, particularly my position because of the cost of health and pension benefits. Of course, this is a picture we can all change with our generosity, but we also eventually had to assess what is within our means.

Second, several people have asked me how this will work for me and Lorinda. I am thankful for all the concern. Obviously there will be personal adjustments my family has to make. However, it doesn't trouble me greatly. In the years I have served here we have lived on a single full time salary (mine) all the way up to 2 full time salaries just the last couple of years after Lorinda started serving her current charge. We have seen our household income go up and down through the years and this will actually still be the second highest income we have had since we came. I think we will be okay. Members have been thoughtful to wonder how I will manage my responsibilities with less paid time. I will have conversations with the council about what should be the highest priorities for the pastor. As a practical matter, I expect to have one additional day a week where I will not be working. If there are appropriate opportunities, I might be open to other work to help with my family finances. I would consult with the council about any such possibilities.

Third, I am hopeful that a new, even exciting set of partnerships for doing ministry will emerge in time, if we are watchful and creative. At our last council meeting, Pastor Jim Davis who has been leading a cooperative ministry centered on Zion Lutheran in Gowrie, spoke to us about their experience. Many congregations in our area are facing similar challenges—it is a theme of rural ministry in our time. I am excited about the church learning how to engage in ministry in new patterns across our region. If we can stay focused on how congregations can provide quality ministry by being good neighbors with one another—not just sharing expenses of a pastor, but seeing ourselves in mission together—I think something fruitful and hopeful will come into being. It will help your pastor but it will help you too and most of all it will be faithful to Christ. Our council will be looking to develop these opportunities.

Fourth, I want to acknowledge the feelings this kind of decision evokes in us. I realize that many may feel some shame or embarrassment that St. Paul's can no longer pay its pastor full time. It can feel like we have failed. That's entirely normal. Thank you for your love of the congregation if you are feeling that way, but I hope you will also trust me when I say you can let those feelings go. We are in a time where even when congregations do everything right, people and resources don't always increase. The causes go well beyond us. They are problems to be solved. We work on those still within the promise that the church is a creation of the Holy Spirit and it has the promise of Jesus that he 'will not let the gates of Hades prevail against it (Matthew 16:18)." This isn't, of course, what we would like. Never forget, though, God is still with us. Our future as a congregation isn't determined by budgets but by our faith and zeal for the mission of the Gospel.

One of the strengths of St. Paul's—it's Lutherans and Presbyterians as well as the former members of the Skaar-borg church—has been our adaptability for the sake of mission. You have never let a past hold you back from doing something for the future. We have renovated old church buildings to our needs, moved pipe organs, formed a new and wider life together with fellow Christians several times before. I believe you will show these strengths again. I am excited about where God is leading us.

PASTOR'S REPORT: Vacation 3 days, 1 baptism.

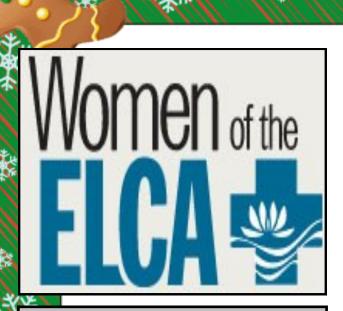
President Kyle W. adjourned the meeting.

Mental Health First Aid - Youth & Adult

Hello! I am Todd Anderson, a Prevention Specialist for Community and Family Resources and Project Director of a national grant that offers FREE Mental Health First Aid (MHFA) training to Boone, Calhoun, Hamilton, Humboldt, Pocahontas, Story, Webster, and Wright counties to educate and train local Iowans to recognize, reach out, and refer to the appropriate services any youth or adults diagnosed with a mental health problem or experiencing a mental health crisis.

Qualifying for this training are participants ages 18+ who are employed by, work with, or related to someone in the professions below:

- First-Responders (Public Safety, EMT, Fire/EMS, Emergency Management), including staff, service providers, and family and loved ones.
- Education (private or public; daycare, pre-K, elementary, secondary, post-secondary) including staff, service providers, and family; students (18+ only), including family and loved ones. (NOTE: This training does not count toward teacher re-licensure in Iowa, per ISEA's policy.)
- **Military** (veterans, active/inactive duty), including staff, service providers, family and loved ones.
- Older Adults, including staff, service providers, and family and loved ones.
- Faith-based Organizations, including staff, family, and loved ones.

Participants may be eligible for CEUs based on employer requirements. This training includes interactive activities and encourages participation. Those who become certified Mental Health First Aiders will also be encouraged (but not required) to track interventions they initiate via brief, quarterly online surveys.

When Lexi found out she was pregnant, she felt scared. She didn't have a job or an apartment, and she was overwhelmed as she tried to prepare for her baby. She knew she needed guidance and support, and she knew where to turn. In high school, Lexi utilized LSI's Behavioral Health Intervention Services, where she developed skills like anger management and healthy communication through regular meetings with her LSI worker.
