8/19 Minutes from the Finance minutes of the 11th April 2019: Resolved that the Minutes of the 11th April 2019 that having been circulated and read were signed as a true record.

9/19 Report of the Responsible Finance Officer: Each member of the Council received a RFO report and a cheque list for May. Lloyds Bank account and payments for the Councillor's Members allowances by Standing Order is still un resolved. The RFO will pursue this option.

11/19 Finance

- 11.1 Approval of accounts for May 2019, to be taken to full council. It was proposed by A. Follows and seconded and agreed to pass the cheques for approval and the exact total will be updated. Cllr. Hinsley spoke on relevant information regarding a donation to the Parish Council of Asda Gift tokens and the amount that will be down as a cash sum received on the accounts will be £500. It was agreed that Cllr. Hinsley can be reimbursed for expenses of the allotment maintenance of fencing and tap replacing with the Asda token to the same value. The RFO has the receipts. Chair of Finance asked that the updated figures be available next month.

- 11.3 Purchase of Retirement keep sake for B. Mulready for long service to the KPC: A wooden bench is being considered. Cllr. A. Follows will look more into the details.
