

**MEETING MINUTES

Minutes of a regular public meeting of the Board of Park Commissioners of the Harrisburg Township Park District, Saline County, Illinois, held in the District Office, 921 W. Poplar Street, Harrisburg, Illinois, in said Park District at 8:00 o'clock a.m., on the 23rd day of September, 2022.

CALL TO ORDER: The meeting was called to order by President Richard Rumsey at 8:00 a.m.

ROLL CALL: Upon the roll being called, Richard Rumsey – the President and the following Park Commissioners, Doug Emery – the Vice President and Mike Williams – the secretary, were physically present at said location 921 W. Poplar Street, Harrisburg, Illinois.

ANNOUNCEMENT: The Executive Director announced that the next Agenda item for the Board of Park Commissioners was a Public Hearing (the “Hearing”) to receive public comments on the proposed Ordinance 2022-0923 Budget and Appropriation Ordinance for Fiscal Year July 2022 through June 2023 (the “Ordinance”). The meeting was opened for public comments.

ORDINANCE:


Upon the roll being called, the following Park Commissioners vote AYE:

The following Park Commissioners voted NAY: None


Whereupon the President declared the motion carried and the Hearing was finally adjourned.
