Seven Oaks Art League 17th Annual Juried Show
Ramco Framing & Design

- Eligibility:** You must be a paid member of Seven Oaks Art League by December 31, 2018
- Entry fee:** **\$20 for one or two entries, you may also enter a third painting for an additional \$10**
All artwork must be entirely original (not a copy of another artist's work and not done under the supervision of an instructor). Artwork must have been completed within the last three years and not previously entered in a SOAL juried show. All two-dimensional work done on paper must be **framed** and ready to **hang with wire** (no saw tooth hangers or clip frames). Unframed work on canvas must have finished edges and wire hanger. (No staples showing or taped sides will be accepted.)
- Size:** No artwork larger than 48 inches in any direction, including the frame. 3D work must be free standing and no larger than 12W x 12D x 24H.
- Juror Bio:** Michael Story - Michael earned a BFA in Fine Art from the University of South Carolina in 1976. He later traveled to New York, studying pastel and oil painting under internationally know artist, Daniel Greene.
- Today, Michael Story is an award-winning artist who regularly teaches pastel and oil painting, guest lectures, and juries art shows. His client list of private buyers and corporate collectors continues to grow, including the Marriott Corporation, Progressive Energy of Florida, the Sanctuary at Kiawah Island, Holiday Inn, Fluor Corporation, Erving Texas, and Walt Disney World. Story has work showcased in the Bush Presidential Library in Houston. His paintings have been reproduced by major publishers such as Canadian Art Prints of British Columbia and distributed worldwide.

If you are not able to deliver or pickup your work during the scheduled times, please make arrangements with another artist to take care of your work.

Although we will take the utmost care in handling your artwork, the Seven Oaks Art League and Ramco Framing & Design will not be responsible for any damage or theft of any artwork during this show. The art league reserves the right to refuse any piece that doesn't conform to the prospectus.

Please remember that SOAL requests a 10% commission on any sales made as a result of our exhibitions and is due within 30 days of the close of the show.
