

# Town of Lacrosse Council Regular Meeting Minutes July 13, 2020

**The Regular Meeting was called to order  
Pledge of Allegiance was recited**

**Present:** Mayor Dianne Dubberly, Vice Mayor Barbara Thomas, Councilman Anthony Kelley, Councilman Sheila Dubberly, Councilman Jishnu Dasa Fitch, Accountant Choi Choi and Town Clerk Lee Forzly **Absent:** Attorney John Maines and Councilman Johnny Ho

Councilman Kelley made the motion to approve the minutes from the Regular Meeting on July 13, 2020. Councilman Fitch seconded the motion. There was no discussion. Vote carries unanimously

**Budget Report:** Accountant Choi Y Choi

Choi reported all revenues and expenses were normal as usual for June 2020. Choi discussed the increase of payment to Gloria for cleaning the Park. Currently, we pay Gloria the half of the month for \$150 (\$100 for the park and \$50 for Townhall), and \$125 in the second half of the month for the Park. The increase was to pay Gloria an additional \$25 in the first half of the month for the park. This is for her to bleach the tables at the park to keep it clean. Based on the council discussions, there was no need. Thus, the increase of payment was not approved.

The cash balance for the General Fund \$56,943; Fire \$28,258; Street \$243,001 Money Market \$71,156; CD \$18,189 and WSPP \$58,504. Total \$476,052. Choi mentioned that she had transferred \$15K from the Gen fund and \$10K from the Fire fund back to the Money Market for the money borrowed at the beginning of the year for purchase of the truck.

**Fire Department:** Commissioner Barbara Thomas, Fire Chief Buddy Harris, Assistant Fire Chief Leonard Reeder and Deputy Chief Chris Miller

a. Call Report: There were a total of 30 calls. LaCrosse Town Limits -2, Alachua Town Limits- 7, Total Ems in Gainesville – 2, Total Ems calls in District 22 but not in town limits – 30. No Fire related calls and no special detail calls.
