**The parties agree as follows:** The student and/or the student's Parent/Guardian, agrees to pay LEGACY DRIVING SCHOOL OF ANDOVER, LLC tuition for a complete (14) hour driver education course which consists of (8) hours of classroom instruction and (6) hours of Behind-the-Wheel driving.

**Behind-the-wheel driving instruction** shall be scheduled at times that are convenient and as agreed upon by the student and the driving instructor.

**Refund Policy:** The initial enrollment deposit to secure classroom registration and to officially enroll is nonrefundable and can be used for a future class within 6 months from the time of initial enrollment date.

The LEGACY DRIVING SCHOOL OF ANDOVER, LLC, agrees to conduct the school in accordance with rules and regulations of the Board of Education of the State of Kansas. A copy of the rules and regulations is available in the classroom. This course usually fulfills the state driving and written test for Driver Education graduates; however, the DMV has the right to randomly test or deny any license applicant. Governing rules mandate that driving schools can make no guarantee to the Student that course completion assures a driver's license from the State of Kansas.

The student and the Parent/Guardian state that the student is at least 14 years of age or older, and is able to fulfill this agreement. The LEGACY DRIVING SCHOOL OF ANDOVER, LLC, reserves the right to dismiss from the course, without refund, any student who is unwilling or unable to fulfill this agreement in a reasonable amount of time or in a manner that is uncooperative or disruptive in the classroom or vehicle.

If additional driving instruction is needed beyond the 6 hours to complete the necessary driving skills and/or requirements, and it is agreed upon by the parties, a rate of \$50 per hour will apply. Students with no experience or have limited opportunity to practice, sometimes needs extra driving hours beyond the required 6 hours.

LEGACY DRIVING SCHOOL OF ANDOVER, LLC, agrees to provide the student with a valid **Kansas Temporary Permit** upon successfully completing the 8-hour classroom session and full payment of course. **A Kansas Certificate of Completion will be given when the student successfully completes the entire (14 hour) course.** If student loses the Certificate of Completion, a fee of \$10 will be charged for a replacement.
