

**RESOLUTION TO DISCONTINUE YELLOW BANK ROAD PURSUANT TO  
§ 66.1003(4)(a) *et seq*, STATS.**

The Chicog Town Board Finds and Orders as Follows:

1. Pursuant to §66.1003, Stats., the Chicog Town Board acting on its own behalf finds the Yellow Bank Road lies within the United State of America National Park Service pursuant to the 1968 Wild Rivers Act which federal agency wishes to discontinue and vacate. Such discontinuance is deemed to be in the public interest.
2. The legal description of the public way to be discontinued is:

**Yellow Bank Road as presently laid out whose centerline commences at its intersection with the centerline of Burian Place Road 707.88'± West of the Section corner of Sections Sixteen (S16), Seventeen (S17), Twenty (S20) and Twenty-One (S21), along the Quarter Section Line lying between Sections Seventeen (S17) and Twenty-One (S21) of Township Forty-One North (T41N) of Range Thirteen West (R13W) in the Town of Chicog, Washburn County, Wisconsin; thence Southeasterly± to a point at its intersection with the North-South Section Line lying between the stated Sections Twenty (S20) and Twenty-One (S21) 946.20'± South of that Line's intersection of the stated Sections Sixteen (S16), Seventeen (S17), Twenty (S20) and Twenty-One (S21); thence Southerly± along the stated North-South Section Line a distance of 658.00' to the end point. Together with a 4-rod right-of-way.**


3. There are no other owners of property abutting these public ways within 2,650 feet of the ends of the portions to be discontinued that have not already been vacated.
4. Discontinuing Yellow Bank Road will not result in landlocked parcels.
5. The Town of Chicog has not maintained this road for over five years.
6. There are no residences or properties serviced by Yellow Bank Road.

**NOW, THEREFORE, BE IT RESOLVED**, that


1. This initial resolution shall be the subject of a public hearing prior to the regular November meeting of the Chicog Town Board with approval to follow on the regular meeting agenda.
2. A Class III notice shall be published in the Spooner Advocate pursuant to § 66.1003(8)(b), Stats., stating the time, date and place of such public hearing described the public way to be vacated.

3. A copy of this resolution shall be mailed to owners of the properties lying within 2650 feet of the end points of Yellow Bank Road.
4. A *lis pendens* pursuant to §840.11, Stats., shall be considered a part of these proceedings. Section 66.1003(9), Stats.
