Minutes of a regular public meeting of the Board of Park Commissioners of the Harrisburg Township Park District, Saline County, Illinois, held in the District Office, 921 W. Poplar Street, Harrisburg, Illinois, in said Park District at 8:00 o'clock a.m., on the 20<sup>th</sup> day of September, 2024.

**CALL TO ORDER:** The meeting was called to order by President Doug Emery at 8:00 a.m.

**ROLL CALL:** Upon the roll being called, Doug Emery – the President and the following Park Commissioners, Raymond Gunning – the Vice President and Ron Emery – the Secretary/Treasurer, were physically present at said location 921 W. Poplar Street, Harrisburg, Illinois.

**ANNOUNCEMENT:** The Executive Director announced that the next Agenda item for the Board of Park Commissioners was a Public Hearing (the “Hearing”) to receive public comments on the proposed Ordinance 2024-0920 Budget and Appropriation Ordinance for Fiscal Year July 2024 through June 2025 (the “Ordinance”). The meeting was opened for public comments.

**ORDINANCE:**


Upon the roll being called, the following Park Commissioners vote AYE:  
President Doug Emery, Vice President Raymond Gunning, Secretary/Treasurer Ron Emery


The following Park Commissioners voted NAY: None
