This agreement for propane fuel delivery is between Freedom Oilfield Services, Inc. (Company) and Customer listed above.

It is understood that by signing below, **Customer** is accepting the above selected fuel delivery scheduling preference and accepts the Company Fuel Delivery Terms outlined on page 2.

It is further understood that Company must first accept this agreement before it becomes effective. Company may revoke this agreement at any time for any reason, with or without notice. Company may also refuse to deliver for any reason, including failure to meet any of the terms of this agreement or the Fuel Delivery Terms.

Customer is responsible for ensuring the propane storage equipment (including the tank, piping, fittings, connections, gauges, etc.) complies with all applicable regulations, standards, and codes, including those related to use and safety. Combustible materials shall not be stored within 10 feet of the tank to be filled by Company, and structures and sources of ignition shall be distanced from the tank as required by the LP Gas Code or by Company.

Customer is also responsible for monitoring fuel level in the propane storage equipment. Company is not responsible for either direct or indirect damages, injuries, or liabilities caused by the use of propane or by freezing temperatures due to outage. Any time there is an interruption in service, including if tank runs empty, **Customer** will be responsible for costs to complete a leak inspection, during which Customer must be on-site. Company will not deliver propane if the leak test indicates there is leakage in the equipment.

Customer shall indemnify, defend and hold harmless Company against any and all losses, damages, claims or demands, including reasonable attorney's fees, whether for injury or damage to persons, loss of life, or damage to property arising out of, or claimed to arise out of, or in any way connected to the propane storage equipment, the propane, or the services or work performed pursuant to this Agreement.

By signing below, Customer acknowledges that both documents have been read (this "Service Agreement" and Company "Fuel Delivery Terms" outlined on page 2), and are understood by **Customer**.

Fuel Delivery Terms

Payments and Fees:

Customer will pay for all LP gas supplied by the Company according to the rates at time of delivery. Any deliveries or service calls which are not ordered during regular business hours or outside regular routing may be subject to additional charges. An additional charge of 1-1/2% per month (an annual rate of 18%) will be charged on all invoices which are over thirty days past due. Balances must be paid in full before any future deliveries will be made (excluding Budget Plan customers). A charge of \$35.00 to perform a leak and pressure test will be applied to Customers whose tanks are empty upon delivery, for which Customer must be present. It is the Customer's responsibility to monitor tank percentage.

License, Fees and Taxes:

Customer will acquire and pay any license, permit, and inspection fees, or other taxes imposed upon or with respect to the delivery, installation, storage, or use of LP gas or equipment installation location. If Company acquires and/or pays the same, Customer will reimburse Company upon receipt of the Company's invoice.

Right of Entry:

Customer agrees to maintain the safe ingress/egress, free from obstacles, from the closest public roadway to the installed equipment. Company or its agents may enter upon the installation location at all reasonable times for the purpose of providing LP gas to Customer. Customer agrees to release and hold Company harmless from any claims or damages that may arise as result of LP gas delivery to my home, including, but not limited to, damage to sprinkler systems, septic systems, driveway and tire tracks in Customer's yard. Customer will be solely responsible for any costs associated with removal of Company delivery truck if stuck while delivering LP gas to Customer home.

General:

This agreement constitutes the entire Fuel Delivery and Payment Agreement between Customer and Company and replaces all prior Agreements, both oral and written. No oral promises, understandings, warranties – expressed or implied, shall be deemed part of this Agreement. No alterations, amendments, or waivers shall be binding upon the Company, unless it is in writing and signed by the Company's authorized representative. This agreement shall be governed by the laws of the State of Wyoming.
