After the 6th attempt on content we will suggest for you to attend a review session of class when it is offered again according to the schedule. There will be no fee to you for this sessions if you come to the scheduled session within 60 days of your original class time . There are no Exceptions to this rule!! We do not round grades. Nor do we give participation credit. And as a student you should not want participation credit because you should want to know that you have successfully mastered the material enough to go take the Alabama State Exam . Again no Exceptions! You must successfully pass the course.** Benefit Solutions School of Insurance **do not** recommend students pre-registering for the State of Alabama Insurance Producer **Exam prior to attending and passing class due to the fact that if you pre register and do not successfully complete the course with the above requirements you will forfeit your registration fee** .
