VVMA BY-LAWS Amended 03/09/2007



Article IV: Board of Directors; Selections; Terms of Office

- **4.1 Activities and Affairs of the Association.** The activities and affairs of this Association shall be administered and overseen by, and the powers of the Association exercised under the direction of, a board of directors. The Board may delegate the management activities to any management company, managing agent or officer of the Association, provided, however, that the activities and affairs of the Association shall be directed, overseen, and managed, and the corporate powers exercised, under the ultimate direction of the Board.
- **4.2 Number and Qualification.** The affairs of this Association shall be managed by a board of not less than five (5) nor more than seven (7) directors, all of whom must be Members of the Association residing in the Project and in good standing as defined in section 3.3 herein.
- **4.3 Term of Office.** Prior to the regular meeting of Members held in December of each year, the Members shall elect the authorized number of directors for a term of two years. Each director, unless he or she vacates his or her office sooner, shall hold office until his or her term expires and a successor is elected. The expiration of the terms of the directors shall be staggered so that for a board of seven directors, three (3) directors shall be elected in one year and four (4) directors shall be elected in the next year. A member may serve no more than two consecutive terms as a director; provided after serving two consecutive terms, such member may run again for a seat on the Board after one year off the Board.

Article VIII: Officers and Their Duties

- **8.1 Enumeration of Officers.** The officers of this Association shall be a President, a Vice President, a Secretary, and a Treasurer, who shall not be members of the Board of Directors, an Office Director who shall be a member of the Board, and other officers as the Board may from time to time by resolution create. No person may hold more than one office at a time.
- **8.2 Appointment.** The officers shall be appointed by the Board of Directors and such appointment shall take place at the first meeting of the Board of Directors following each annual election of directors.
- **8.3 Term.** Each officer of this Association shall be appointed annually by the Board and each shall hold office for one year unless he or she sooner resigns or is removed by the Board. A person may be appointed to successive terms in any officer position.

To summarize, Directors are voted into office by the members or by acclamation. Officers are appointed by the Board of Directors.



2026 BOARD ELECTIONS NOMINATIONS OPEN

A new Board of Directors will be seated at our January Board meeting. We will have (4) open seats to fill. Gwen Farrell, Karen Rohyans, and Betty Young will complete their 2-year term. Cheryl Lyman is vacating a position on the Board leaving 1-year of a 2-year term to be filled.

At our July Board meeting, approval was given for a Nominating Committee composed of Gerry Runz, Kathy Leeks Dean, and Maggie Chenet. We keep our monthly assessments low, managing the property and the business of the Association ourselves. Keeping assessments low depends on members stepping forward to do their part. Contact any Board Member, if you are interested in joining the Board and meet the following requirements:

- You are a member/owner of the Association. (See CCRs 1.20 And Bylaws 3.1 for definition of member.)
- You are current in all assessment payments. (see Election Rules 2020)
- Your election will not result in two members who own a single lot serving at the same time.
- You have been a member for at least 1 year.
- You have not been convicted of a felony that would affect the Association's ability to obtain or maintain a fidelity bond.


You may nominate yourself by calling any Board Member, at a Board meeting or at our Candidates Open Forum on September 20^{th} . Qualified Candidates will have equal unedited access to the Peacock Press (not to exceed $8 \frac{1}{2} \times 5 \frac{1}{2}$ space for each candidate), the website, equal time at the Forum to present, and use of the Clubhouse at no cost (except for any damage or cleaning required after use). Candidates will be vetted as of that date to assure each meets the above qualifications. No Association funds will be used for any candidate's campaign.

At the close of the Candidates Forum should there be the same number or fewer qualified candidates as there are board positions to be filled, the Board will seat the qualified candidates by acclamation without balloting at the October Board meeting.

Should there be more candidates than there are board positions to be filled, ballots will be sent out as soon as vetting is complete. The ballots will be counted, and the election will take place on December 6th. Our Annual Meeting will be held on that same day.

Please *step* forward and do your part. It takes all of us to make a community.

NAN KOONTZ (227 Monarch) grew up in St.

Helena, the daughter of 1st generation Italian Americans, Adolph Magri and the former Frances Branchini and has one sister, Rosemary. Growing up in a traditional Italian family was always very loud; if it was quiet then something was very



wrong! From early on, Nan wanted to be a writer... no wait, a tap dancer... no wait, an actress or to work in the theatre in some capacity. And she has pretty much realized all those dreams in one way or another.

Nan wrote her first two novels about a nurse in the 3rd grade. She attended St. Helena High School where she was bit by the acting bug and the first time she tried out, got the lead in *The Happy Journey to Camden and Trenton*, where she had to speak with a southern accent. She was also Stage Manager with her good friend, Jane Hailey, the daughter of acclaimed author, Arthur Hailey,* who lived in St. Helena at the time.

After high school, Nan attended Napa College, where she and another good friend, David Holmes, got parts in *You're a Good Man, Charlie Brown*, starring Nan as Lucy, perfect typecasting according to friends! She and Dave also started a theatre company that performed at the St. Helena Elementary School. Dave cast Nan and a local boy, Timothy Spenser, who was home from Sacramento State for the summer, in a one-act melodrama. Nan and Tim became an item, with Tim deciding to take a break from school and move back to Napa Valley. They moved in together in a tiny cottage in Calistoga and were married within a year.

After a string of odd jobs, including appliance sales, food service, bench grafting, shade factory work and bottling wine, she took the Clerk-Typist test and got a job at Napa State Hospital. She squeezed in one more performance in the musical, *Valley Pie Jubilee*, before relocating to Sonoma County. Tim enrolled in Sonoma State University while Nan went to work at the State Compensation Insurance Fund in the legal department, eventually becoming Office Manager.

When her first marriage ended after seven years, she met and married Stillman Bowden. They have a son, Apollo. That marriage didn't last and after a few years spent learning how to be single, she answered a few personal ads in the Press Democrat (this was *way* before online dating!). One ad submitted by Dale Koontz resonated with her in a way the others didn't. After she and Dale met for the first time, he immediately cancelled the dates he had made with 40 other respondents! They met in September of 1986 and were married in June, 1988. On December 1st of that year their son, Richard, was born.

Thanks to Dale's encouragement and support, Nan left State employment and worked for eight years with Sonoma County Office of Education as a job developer and coach for high school students with disabilities. After retirement, Nan got serious about her writing. She was featured in *Women's Voices* newspaper and the *Living Room's* annual anthology. She has published poems in three anthologies and written two novels. She also co-wrote a screenplay; a romantic comedy called *Birds, Bees and Tea*.

After 38 years of marriage, an adventure that included two Viking River cruises and numerous other memorable escapades, Dale passed away at age 81 on November 24, 2024. To keep busy while learning to fly solo, Nan continues to participate in line dancing with Gerry Runz three times a week in the Clubhouse and hosts a popular writing practice group here in Valle Vista that meets once a month. Two forms are provided to record your emergency contacts, medical information, pet details, and insurance.


The "To Go" Bag document suggests items to pack and provides space for your own additions.
