ORDER

WHEREAS on May 12, 2008 the New Brunswick Securities Commission (Commission) issued an *ex parte* temporary order (Temporary Order) pursuant to subsections 184(1)(c), 184(1)(d) and 184(5) of the *Securities Act*, SNB 2004, c. S-5.5 as amended (*Act*) that

- (a) All trading in securities of Goldpoint Resources Corporation, including but not limited to the solicitation of trades or any acts constituting attempts or acts in furtherance of trading in securities of Goldpoint Resources Corporation, shall cease;
- (b) Goldpoint Resources Corporation, Lino Novielli, Brian Moloney, Evanna Tomeli, Robert Black, Richard Wylie, Jack Anderson and Jim Corcoran shall cease trading in all securities, including, without limitation, the solicitation of trades in securities and any acts constituting attempts or acts in furtherance of trading in securities; and
- (c) Any exemptions in New Brunswick securities law do not apply to Goldpoint Resources Corporation, Lino Novielli, Brian Moloney, Evanna Tomeli, Robert Black, Richard Wylie, Jack Anderson and Jim Corcoran;

AND WHEREAS on May 15, 2008 the Commission issued a Notice of Hearing to be held on May 26, 2008 at 10:00 am;

AND WHEREAS the hearing was commenced on May 26, 2008 and then adjourned to 19 June 2008 to address the substantive issues;

AND WHEREAS on May 28, 2008 the Temporary Order was extended to June 20, 2008 pursuant to subsection 184(7) of the *Act*;

AND WHEREAS neither Goldpoint Resources Corporation, Lino Novielli, Brian Moloney, Evanna Tomeli, Robert Black, Richard Wylie, Jack Anderson nor Jim Corcoran appeared on 26 May 2008 and 19 June 2008 despite having received notice;

AND WHEREAS at the hearing on 19 June 2008, Staff of the Commission requested an adjournment and an extension of the Temporary Order which was extended on May 28, 2008 pending completion of their investigation and their preparation of an amended statement of allegations;

AND WHEREAS the Panel considered the evidence and submissions before it;

IT IS HEREBY ORDERED THAT the Temporary Order is extended until the Commission reaches a final determination in this proceeding or until otherwise ordered by this Commission.
