A RESOLUTION OF THE TOWN OF LACROSSE OF ALACHUA COUNTY, FLORIDA, ADOPTING THE FINAL LEVYING OF AD VALOREM TAXES FOR ALACHUA COUNTY FOR FISCAL YEAR 2018-2019; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of LaCrosse of Alachua County, Florida, on September 24, 2018, adopted Fiscal Year 2018-2019 Final Millage Rates following a public hearing as required by Florida Statute 200.065;

WHEREAS, the Town of LaCrosse of Alachua County, Florida, held a public hearing as required by Florida Statute 200.065; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Alachua County has been certified by the County Property Appraiser to the Town of LaCrosse as \$10,900,089.

NOW, THEREFORE, BE IT RESOLVED by the Town of LaCrosse of Alachua County, Florida, that:

1. The FY 2018-2019 operating millage rate is 6.3686 mills, which is the same as the rolled-back rate.
2. This resolution will take effect immediately upon its adoption.


NOW, THEREFORE, BE IT RESOLVED by the Town of LaCrosse of Alachua County, Florida, that:
