*The expression Specified Thief Attractive Cargo shall have the meaning set out below wherever it appears in this policy, the Schedule, any endorsements and memoranda:  
non ferrous metals during Road Transport on behalf of all customers*

**H3000J**      **General Condition 6 - Thief Attractive Cargo**  
*General Condition 6 is restated as follows:  
The maximum amount We will pay for any claim for theft of Thief Attractive Cargo is:*  
a) £39,000 any one Event and £39,000 any one Vehicle in respect of Specified Thief Attractive Cargo  
b) £75,000 any one Event for any other Thief Attractive Cargo increased to £250,000 any one Event in respect of Cargo carried in a sealed Container or as part of a groupage load provided that You can prove to Our satisfaction that prior to the theft neither You nor any Employee had any reason to believe that the stolen Cargo was Thief Attractive Cargo  
or any applicable Section Limit or Sub-limit if lower.  
All limits under this clause are subject to the deduction of any applicable Excess and/or any applicable coinsurance.

**B6001G**      **Theft Exclusion**
