My four-year record speaks for itself. More than 70 times, my vote went against the majority because what was being proposed didn't pass muster as something beneficial to the people of the County. With our economy taking a huge hit due to the COVID19 shutdown, shifting county leadership and resources to meet the challenges we now face tops my list of Commissioner goals. Volunteered at various Carson Valley charities as well as the DCSO. Elected to the secretary position in the DCRCC.

I decided to run for Douglas County Commissioner, District 5 after observing a steady progression of development over the years. I saw the BOCC as a liberal organization with a liberal agenda rather than one that had the best interests

of the residents in mind. After seeing a steady progression of 3-2 votes I decided that it was time for me to vie for a seat on that board. One of my concerns was Redevelopment Area 2. I saw that blight was an excuse to come to the aid of the casinos. An "independent" study was conducted under the broad terms laid down by the legislature and that study concluded that because the tourist attraction of legal gambling had run its course; it was economically blighted. My experience with blight comes from my time in both Detroit and Chicago. Given the fact that I lived in those areas, I know what blight looks like, and it's not in the Township of Lake Tahoe. Additionally, I believe that the purpose of government at whatever level, is to provide those services that individuals cannot provide on their own: law enforcement, water, sewer disposal, schools, parks, libraries, roads, among others. One of the services a county should provide is real blight control. If a property falls below that standard, it is not government's option to "rescue" a homeowner when his property falls below that standard, it is to serve notice to the homeowner to correct the problem. So my vote would be a yes to rescind RDA2.
