Budget Report: Accountant Choi Y Choi

Choi reported all revenues and expenses were normal as usual for August 2020. For the Fire Fund, Choi discussed that we made our first truck payment for \$8,095, and the majority of the building maintenance expense was for the washer (\$1208) and repair for the engine for \$1910 in Equipment Maintenance. The cash balance for the General Fund \$53,997; Fire \$4,722 Street \$266,045 Money Market \$71,180; CD \$18,189 and WSPP \$63,712. Total \$477,846.


3. Parks and Recreation – Councilman Fitch- absent from meeting

4. Streets and Streetlights- Councilman Ho. – nothing to report


5. Website-Councilman Kelley- Nothing new to report-
