Shadow Lake Road Culvert Issue Moved to July Agenda.

Updating Library Building Restrooms-Floor Joanne would like to have vinyl flooring put down. The selectmen Okayed and also said to have the toilets in the bathrooms updated to higher and more efficient American Standard toilets.

Fire Dept. Rescue Truck Replacement Update Fred reported that he has been meeting with Kevin Fontecha and his crew to review options for a replacement rescue truck. Both the Fire Department and Fred agree on the selection, and Fred reported that it appeared the Unit could be leased with minimal impact on the Fire Department Equipment Fund and annual appropriation. Brent made a motion to proceed with acquisition of the Unit and Gary seconded the motion. The motion was approved unanimously.

Model Class 4 Highway & Trail Policy Jessy presented the Selectboard with a packet of information regarding all of the needed documents to apply for a grant for a possible recreation path. The deadline is the beginning of July and the Selectboard agree it is not feasible at this time.

The selectmen discussed reaching out to a few people who they think may be interested in this kind of a project. Gary will get in touch with David Morrison, Marcel Gingue and a few other residents to see if they would be interested.
