- Ron Smith – Rec Dept.: Ron found two lights out at the basketball court/skating rink and the ballfield. - Tony Carroll – Water/Sewer District: He was hoping to have the new well on-line by December 1st but due to shipping delays for some parts it won't be ready till late January. He read a letter from Maine Rural Water explaining the oversight on their part as to why the Limerick Water District received the violation notice.
