Approval of Minutes Regular Meeting 9-12-22: Councilman Kelley made a motion to approve the minutes. Councilman Cheshire seconded the motion. Motion carried.

Attorney - John Maines:

Dominique Wilkerson, Wilkerson Welding, contacted town hall pertaining to semi-trailers parking for days in the FDOT on-street parking spaces in front of his business. He stated the semi-trailers were blocking the view for trucks entering the highway from his business, causing a safety hazard, and he asked if the town could do anything. The mayor contacted FDOT and was told that the town council could request removal of the parking spaces. Following discussion Councilman Cheshire made a motion to remove the parking spaces in front of Wilkerson Welding, as designated on the map from FDOT. Councilman Ho seconded the motion, and motion carried. The mayor will write a letter informing FDOT of the council action.

Alachua County Leagues-of Cities is giving donations to 501C3 Non-profit Organizations for \$350 on behalf of each municipality. Following discussion Councilman Cheshire made a motion to designate the donation from the Town of LaCrosse to the LaCrosse Baptist Church. Councilman Kelley seconded the motion. The motion carried.
