## **MEETING MINUTES** HARRISBURG TOWNSHIP PARK DISTRICT REGULAR BOARD MEETING **MARCH 19, 2021** 8:00 AM HARRISBURG PARK OFFICE



CALL TO ORDER:

President Richard Rumsey called the meeting to order at 8:00 a.m.

**ROLL CALL:** 

The following members of the Board of Commissioners were present: President Richard Rumsey, Vice President Doug Emery, and Secretary/Treasurer Mike Williams.

Park Staff Present: Executive Director Blake Emery, Administrative Assistant Jill Marvel and Maintenance Director TA Sullivan.

Visitors Present: None

**PUBLIC COMMENTS:** 

Blake Emery announced that the Harrisburg Township Park District (HTPD) was accepting public comment by email or written submission up to the start of the meeting at 8:00 AM on March 19, 2021. There were no written comments received and there was no one from the public present on the teleconference call. There was no one from the public present at the meeting.

**CONSENT AGENDA:** 

Richard Rumsey made the motion to accept the February 19, 2021 meeting minutes and seconded by Mike Williams. All in favor 3-0 per voice vote.

Mike Williams made the motion to accept the 2/19/2021 to 3/18/2021 bills and the February 2021 Unaudited Financial Reports and seconded by Richard Rumsey. All in favor

3-0 per voice vote.

**CLOSED SESSION:** 

There was no motion to enter closed session.

## **UNFINISHED BUSINESS:**

COVID-19

Blake Emery presented to the Board the current available information regarding COVID-19. We are currently in Phase 4 of the Restore Illinois Plan. There were recent updates on March 18, 2021 developing a "Bridge" plan between Phase 4 and Phase 5. There is nothing in it that has a negative impact on the park. Blake Emery opened the meeting for discussion on any facilities that we need the current policy/decisions revisited. There was nothing further discussed.

Soccer Parking

Blake Emery presented to the Board that he met with the SYSA Board and the HYA Board and both were in agreement that the soccer parking layout and field concept was in the best interest of the park. SYSA agreed to designate \$10,000 towards construction of the parking lot.

**Beardsley Property** 

Blake Emery presented to the Board that he has not been contacted by anyone regarding purchasing the Beardsley Property. Richard Rumsey stated that he has talked with Bruce Tolley and told him to contact Blake Emery to move forward with any negotiations.

**NEW BUSINESS:** 

Trash Service

Blake Emery presented to the Board that PSD submitted a quote to provide trash service to the park. The cost would be \$125/week for a 6 yd dumpster with once a week pickup. Currently we pay Bulldog \$160/week for a 6 yd dumpster with once a week pickup. There would be no contracts associated with switching. It was discussed that PSD is not a Harrisburg based company (office located in Carrier Mills). Mike Williams said we are a local government of Harrisburg Township and he does not think we should end services with a Harrisburg based company if we do not have any complaints about them. Mike Williams made the motion to approve staying with Bulldog for waste service needs and seconded by Richard Rumsey. All in favor 3-0 per voice vote.

**Running Club** 

Blake Emery presented to the Board that Heidi Flannery and Lindsey Atkins would like to have the Kids Running Club again this summer. They would like to use Taylor Field Track instead of the park walking path. The school district would require us to complete a Request to Use School Facilities. The question of insurance and liability was brought up. Blake Emery will reach out to Williams & Associates to check on the coverage. Mike Williams made the motion to approve the Running Club using Taylor Field Track after confirmation of coverage is received from the insurance provider and seconded by Richard Rumsey. All in favor 3-0 per voice vote.

Dodge Durango

Blake Emery presented to the Board that the 2000 Dodge Durango does not get used and is in need of constant repairs when it does get used. It is recommended to take bids for selling the Durango. Richard Rumsey made the motion to approve taking bids to sell the Dodge Durango and seconded by Doug Emery. All in favor 3-0 per voice vote. Blake Emery will put together a Bid Package.

**HYA Flag Football** 

Blake Emery presented to the Board that HYA is seeking an agreement for Flag Football that is similar to the agreement they have with the park for HYA Baseball/Softball. The Agreement is they pay for field rental for games only and not practices. HYA looks forward to using Gibbs Field / Shaw Street for Flag Football. Mike Williams made the motion to approve entering into an agreement to charge HYA Flag Football for game use rental only and not practice rental and seconded by Richard Rumsey. All in favor 3-0 per voice vote.

Game 7 Baseball

Blake Emery presented to the Board that Jacob Palmer contacted him about an Organization called Game 7 Baseball wanting to host a tournament at the Gaskins City Complex. He said this organization holds tournaments in Illinois, Missouri, Tennessee, and Kentucky and they donate back the proceeds to the host site. All teams that play in the tournament are required to have their own insurance. He said typical revenue is around \$5,000 to \$7,000 for a weekend tournament. Blake Emery will check with Williams & Associates about insurance coverage questions for hosting a tournament. Mike Williams made the motion to approve Game 7 Baseball moving forward with scheduling a tournament at the Gaskins City Complex and seconded by Richard Rumsey. All in favor 3-0 per voice vote. Blake Emery will reach out to Jacob Palmer to discuss any logistics concerns moving forward.
