



DOGGY DAY CARE, BOARDING and GROOMING RELEASE FORM

The undersigned person has registered to participate in either Doggy Day Care, Boarding and/or Grooming at Kinder Kritter, Inc. in Dallas, Texas.

1. I hereby certify that I am the owner of _____,
2. the dog(s) which will participate in Day Care, Boarding and/or Grooming.
3. I understand that other dogs will attend Day Care, Boarding and/or Grooming and that during the course of participation, my dog may come into direct contact with all other participating dogs.
4. I certify that the above-named dog is fully vaccinated, including DHPPC (distemper, hepatitis, parvovirus, parainfluenza, coronavirus), Bordetella (every 6 months), rabies, and canine influenza (H3N8 and H3N2)
5. The requirements to participate in Day Care, Boarding and Grooming are current on vaccines (see above) and monthly treatment of Flea/Tick/Heartworm. I am aware that my dog may be exposed to those infectious diseases described above. However, since Kinder Kritter, Inc. has advised me that my dog must be fully vaccinated against those diseases before attending Day Care, Boarding and Grooming, I alone assume responsibility for any such exposure. I also acknowledge that in addition to the diseases described above my dog may be exposed to other infectious diseases. However, in order for my dog to participate in Day Care, Boarding and/or Grooming, I alone assume the responsibility of such exposure to all other infectious canine diseases.
6. I understand that in the event of injury or illness during his stay, my dog will be taken to A&B Animal Clinic or Hillside Veterinarian Clinic, if after hours unless your personal veterinarian is in close proximity to Kinder Kritter, Inc. and available at the time of the incident.
7. Although Kinder Kritter, Inc. associates diligently watch all dogs play, I am aware that given the sometimes-unpredictable nature of dogs, an interaction could take place between animals at the Day Care, Boarding and Grooming. If such an event resulted in injury to my dog, to other dogs, or to other people, I alone assume responsibility for any such injury.
8. Kinder Kritter, Inc. requires 48-hour notice on canceling Grooms and non-holiday Boarding to not be charged. During holiday time frames (set forth prior by the manager) cancellation must be done within 7 -days of appointment. Cancellations without proper notice are subject to a cancellation fee equaling 50% of the appointment. Last minute and No RSVP are charged Holiday price.
9. As to Kinder Kritter, Inc. and its employees, I hereby waive and release any actions, causes of actions, damages, rights, claims or lawsuits which I may have for: (a) any and all personal injury or property damage which may be sustained arising out of any interaction between dogs participating in Doggy Day Care, Boarding and/or Grooming; and (b) any and all injury, illness or disease sustained by my dog arising out of or stemming from its participation in Doggy Day Care, Boarding and/or Grooming.
