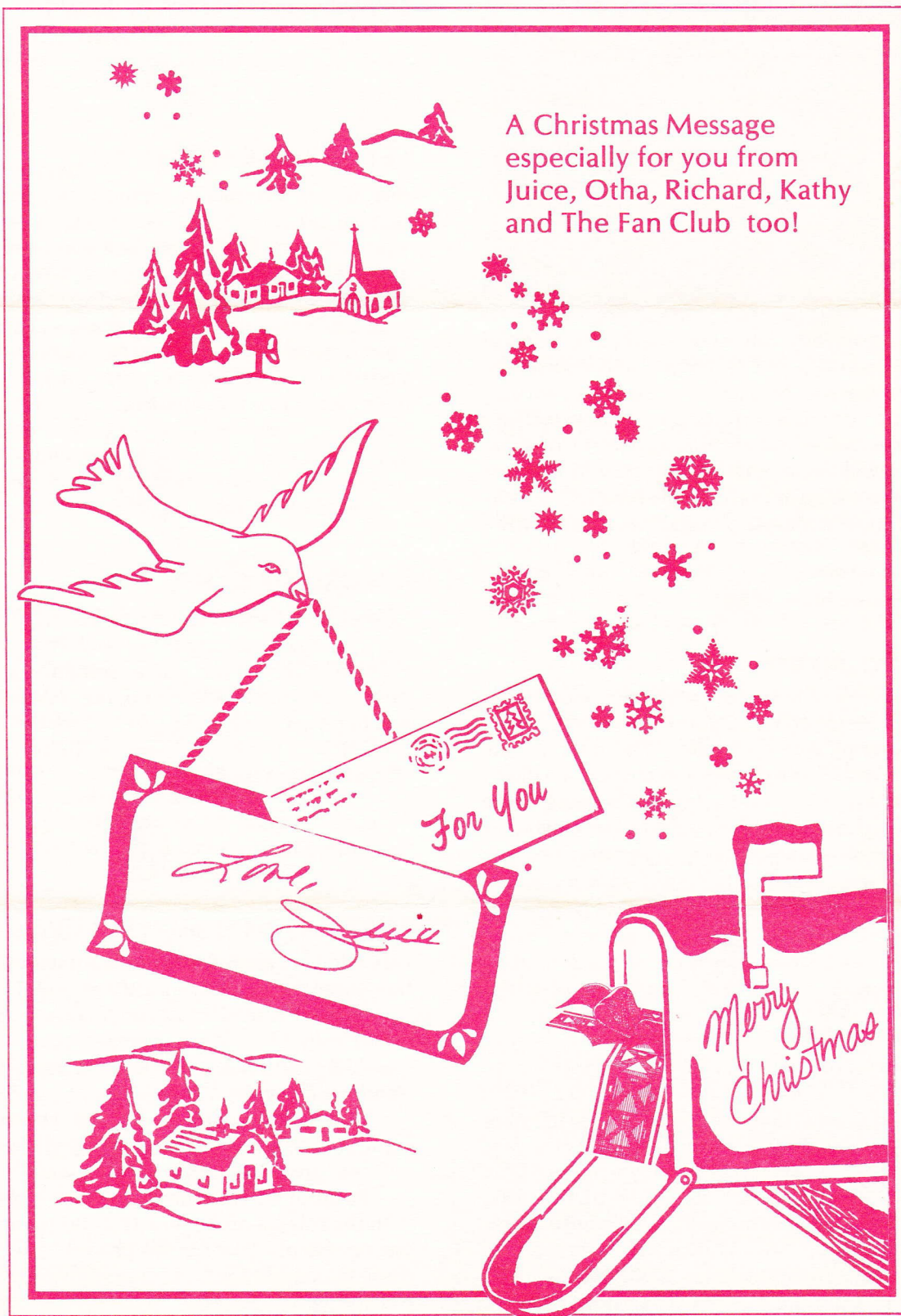

HELLO EVERYONE!

By the time this reaches you the year 1985 will be coming to an end. Juice and her management have been busy the greater part of this year working on the new album "Old Flame." By now, many of you have heard it and even though it has been in the record stores for less than a week, the reports beginning to come in are that every song on the album is good!

As you probably know, the first single from the album "You Make Me Want To Make You Mine" reached **Number One** on the Billboard Country Chart the week of October 14. As the newsletter goes to the printer, the second single "I'm So Hurt" is climbing the charts! A special **thank you** is in order to all of you for your support of this first single — it couldn't possibly have reached *Number One* without your help, and the help of the DJ's across the country!

Because the album and single "Hurt" are being released at the close of October, and due to the fact the printer must have the newsletter material a full four weeks before our mailing deadline, there's no way we can give you a full report on the reception of the album by critics and reviewers, and yourselves. Most likely we will be sending a flyer in February bringing you up to data on tour dates — **there will be a major tour in 1986** — and on other important information so you will know what's going on and not miss anything. We would appreciate any reviews you may find in your newspapers and magazines regarding the new LP "Old Flame."



ANNOUNCEMENT!

We know many of you were waiting anxiously the morning of October 11, as you watched the *Today Show* wondering when Juice would be interviewed, *and you, as we all, were disappointed* when she didn't appear. Juice *did* appear on The Today Show on 11/05/85. We hope you saw it.

Information from Juice's Management . . .

From time to time we get songs from some of you who are aspiring to be songwriters and to *those of you*, we thought we should give you the following information:

1. Make sure the lyrics are audible and above the music;
2. Make sure your songs are copy-written;
3. The best way to have your material shown is to first have it accepted and published by a professional music publisher;
4. Please don't expect a reply. Juice listens to thousands of cassettes a year and the task of replying to each one is impossible;
5. Please don't send the only copy of your song. The cassettes and lyric sheets can't be returned because the mailing costs are prohibitive.

We want to assure you we are happy to receive your songs, but felt we should give you this information to make it easier for all concerned.

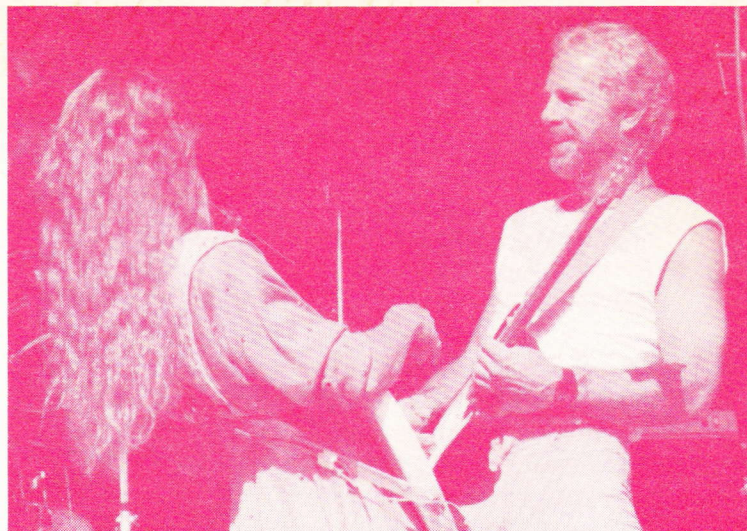


THANK YOU OTHA!

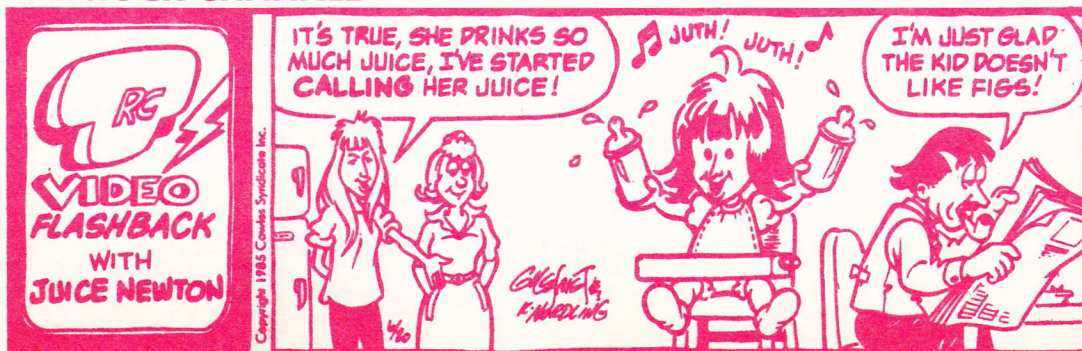
CORRECTIONS ARE IN ORDER!
