The Past, Present, and Future of recording Environmental and Disposal Liabilities

Introduction and “The Past”

For nearly 30 years, we have seen the United States government continue to perform large-scale efforts to identify, assess, and initiate cleanup of the legacy of contamination from its past activities including the creation of federally owned plants and factories, including hundreds of nuclear facilities, large volumes of waste and nuclear materials requiring treatment, stabilization, and disposal, and the world’s large fleet of aircraft and ships. The Department of Defense (DoD or the Department) has historically recognized environmental and disposal liabilities (E&DL) for cleanup of a variety of contamination types at its sites including active and Base Realignment and Closure installations. In addition, DoD has recorded E&DL for military equipment and weapons programs including both nuclear powered military equipment and associated spent nuclear fuel, non-nuclear military equipment, and other weapons systems.

These efforts include the need to estimate costs relating to the identification, assessment, and cleanup of contamination and to account for and present complete and accurate financial information in accordance with relevant accounting standards such as Statements of Federal Financial Accounting Standards (SFFAS) No. 5 and No. 6.

Under SFFAS No. 5, a liability is defined as: “A probable future outflow or other sacrifice of resources as a result of past transactions or events”¹ and a liability should be recorded for “probable and measurable future outflows or other sacrifices of resources arising from (1) past exchange transactions, (2) government-related events, (3) government-acknowledged events, or (4) nonexchange transactions that, according to current law and applicable policy, are unpaid amounts due as of the reporting date.”²

SFFAS No. 6 states that “cleanup costs are the costs of removing, containing, and/or disposing of (1) hazardous waste from property, or (2) material and/or property that consists of hazardous waste³ at permanent or temporary closure or shutdown of associated property, plant, and equipment (PP&E).”⁴

Today, “The Present”

DoD has not yet received an unmodified opinion on its consolidated financial statements. While the Department continues its efforts accounting for E&DL, the DoD Office of the Inspector General’s (OIG) annual audit report continues to cite the Department’s inability to reasonably estimate or substantiate the completeness and accuracy of amounts reported as E&DL as a material weakness contributing to its disclaimer of opinion on the DoD consolidated financial statements.⁵

Where do we go from here? “The Future”

As the DoD continues to refine its methods and improve its processes to account for cleanup costs, the Department should focus efforts on implementing an effective system of internal control, to include controls such as the following:

- Providing training on the relevant accounting standards to agency personnel to develop, implement, and maintain policies and processes over E&DL.
- Establishing and maintaining processes to timely and effectively identify property and materials that may be contaminated and require cleanup through site and asset surveys and physical inspections and reviews performed over historical projects and records.
- Establishing and maintaining documentation sufficient to support recorded E&DL balances are recorded in accordance with the accounting standards.
- Establishing and periodically updating estimation methodologies in a timely manner to ensure the most reliable information available is used to estimate the liability for future cleanup costs, including:
 - Matters identified through the review of newly identified regulations or newly communicated agency directives such as the selection of a cleanup approach or issuance of a cleanup plan, including refinements to cost estimation methodologies.
 - Updates identified through the annual review of key management assumptions and other factors.
 - Changes identified from the comparison of actual costs to estimates once known.
 - Other updates identified through communication with qualified personnel or environmental and other cost estimation specialists engaged by the DoD.
- Designing, implementing, and supporting the effective operation of internal controls over E&DL processes and areas, such as:
 - Documentation of key management assumptions and other factors used in developing the estimates.
 - Management’s review and approval of cost estimation methodologies, assumptions, completeness and accuracy of data used, and accuracy of calculations applied.
 - Specialists’ preparation and review of estimates.

Following the practices outlined above will aid DoD in its continued efforts in resolving deficiencies identified in E&DL, which is one step closer to obtaining an unmodified opinion on the Department’s consolidated financial statements.



While most candidates in the CDFM program are civilian or military/reserve members of the Department of Defense, U.S. Coast Guard, U.S. Army, U.S. Air Force, U.S. Navy, U.S. Marine Corps or employees of defense contractors or suppliers, the CDFM program is open to all candidates who have a high school diploma (or equivalent) and meet the following work experience qualifications:

Have the required number of years of defense-related financial management experience outlined below:

- **Two (2) years if you hold an Associate's degree or higher;** or
- **Three (3) years if you do not have a degree.**

OR

Do not have defense-related financial management experience, but can meet the following criteria outlined below:

- **Four (4) years of Federal government-related financial management experience;** and
- **An Associate's degree or higher.**

There are three steps involved with earning your CDFM:

1. Enroll in the CDFM Program. Your enrollment is valid for two (2) years, during which time you must take, and successfully pass, the three CDFM module examinations.

2. Submit Your Verification of Financial Management Experience Form. This form, which must be signed by a supervisor who can verify your work experience, must be returned to ASMC after enrolling in the CDFM program. You do not have to submit this form prior to taking a CDFM examination, but it is required prior to the awarding of the CDFM designation.

3. Purchase and Schedule the CDFM Examinations. Be sure to carefully – and completely – read the criteria associated with each testing option for the CDFM examinations. Failure to do so can result in the purchase of the wrong CDFM examination and/or the inability to test at your preferred location
