At Early View Academy of Excellence, we teach all subjects as part of an integrated whole, with the Scriptures at the center. Scholars are equipped to know and love the truth and to utilize that knowledge to glorify God in all things.

Why must we hold ourselves and our scholars to standards of excellence?

There is no place for *second-rate* Christian education. We are preparing Milwaukee's next generation of leaders; therefore, we must equip them with the core knowledge to take on the most demanding leadership roles required of the 21st century. An academically rigorous course of study will best prepare scholars to deal purposefully and responsibly with the complex issues of living in this present society.

Doctrinal Statements

WE BELIEVE...

The Bible

The Bible is the inspired Word of God, giving a true history of the creation of heaven, earth, and humanity and containing a correct prophecy of the ages to come regarding heaven, earth, and the destiny of humanity. Moreover, there is no salvation outside of what is taught in its pages.

God

There is only one God (Deuteronomy 6:4). He is the creator of heaven and earth, and of all living beings. He has revealed Himself to humanity as the Father (Creator), in the son (Savior), and as the Holy Ghost (indwelling Spirit).

Father

God is a Spirit (John 4:24). He is the Eternal One, the Creator of all things, and the Father of all humanity by creation.

He is the First and the Last, and beside Him there is no God (Isaiah 44:6).

There was no God formed before Him; neither shall be there any after Him (Isaiah 43:10).

Son

Jesus is the Son of God according to the flesh (Romans 1:3) and the very God Himself according to the Spirit (Matthew 1:23). Jesus is the Christ (Matthew 16:16); the creator of all things (Colossians 1:16-17); God with us (Matthew 1:23); God made flesh (John 1:1-14); God manifested in the flesh (I Timothy 3:16); He which was, which is, and which is to come, the Almighty (Revelation 1:8); the mighty God, everlasting Father, and Prince of peace (Isaiah 9:6).

Jesus Himself testified of His identity as God when He said, "He that hath seen me hath seen the Father" (John 14:7-11) and "I and my Father are one" (John 10:30).

It took shedding of blood for the remission of the sins of the world (Hebrews 9:22), but God the Father was a Spirit and had no blood to shed. Thus, He prepared a body of flesh and blood (Hebrews 10:5) and came to earth as a man to save us, for in Isaiah 43:11 He said, "Beside me there is no Saviour." When He came in flesh the angels sang, "For unto you is born this day in the city of David a Savior, which is Christ the Lord" (Luke 2:11).

Holy Ghost (Holy Spirit)

The Holy Ghost (Holy Spirit) is not a third person in the Godhead, but rather the Spirit of God (the Creator), the Spirit of the resurrected Christ. The Holy Ghost comes to dwell in the hearts and lives of everyone who believes and obeys the gospel, as the comforter, Sustainer, and keeper (John 14:16-26; Romans 8:9-11).

Sin

Sin is the transgression of the law, or commandments of God (I John 3:4). The guilt of sin has fallen upon all humanity from Adam until now (Romans 3:23). The wages of sin is eternal death (Romans 6:23; Revelation 20:14) to all those who refuse to accept salvation as set forth in the Word of God.

Salvation

Salvation consists of deliverance from all sin and unrighteousness through the blood of Jesus Christ. The New Testament experience of salvation consists of repentance from sin, water baptism in the name of the Lord Jesus Christ for the remission of sins, and the baptism of the Holy Ghost, after which the Christian is to live a godly life (Acts 2:36-41).

Water Baptism

Water baptism is an essential part of New Testament salvation and not merely a symbolic ritual. It is part of entering the kingdom of God (God's church, the bride of Christ), and therefore, it is not merely a part of local church membership. (See John 3:5; Galatians 3:27).

Mode of Baptism

Water baptism is to be administered only by immersion. Paul said, "We are buried with him [Jesus Christ] by baptism (Romans 6:4; see Colossians 2:12), Jesus came up "out of the water" (Mark 1:10), and Philip and the eunuch went down "into the water" and came up "out of the water" (Acts 8:38-39).

Jesus' death, burial, and resurrection are applied to our lives when we experience New Testament salvation: "Repent [death to sin], and be baptized [burial] every one of you in the name of Jesus Christ for the remission of sins, and ye shall receive the gift of the Holy Ghost [resurrection]." (See Acts 2:38; Romans 6:1-7; 8:2).

Sprinkling, pouring, or infant baptism of any kind cannot be substantiated by the Word of God, but are only human traditions.

Formula for Baptism

The name in which baptism is administered is vitally important, and this name is Jesus.

Jesus' last command to His disciples was, "Go ye therefore, and teach all nations, baptizing them in the name of the Father and of the Son, and of the Holy Ghost" (Matthew 28:19). We should notice that He said name (singular) not names. As previously explained, Father, Son, and Holy Ghost are not names of separate persons, but titles of positions held by God. An angelic announcement revealed God's saving name in the New Testament: "She shall bring forth a son, and thou shalt call his name JESUS: for he shall save his people from their sins" (Matthew 1:21).

The apostles understood that Jesus was the name to use at baptism, and from the day that the church of God was established (the Day of Pentecost) until the end of their ministry, they baptized all nations (Jews–Acts 8:16; Gentiles–Acts 19:5) in the name of the Lord Jesus Christ. In fact, Jesus is the only name given for our salvation. "Neither is there salvation in any other: for there is none other name under heaven given among men, whereby we must be saved" (Acts 4:12).

Baptism of the Holy Ghost

The baptism of the Holy Ghost is the birth of the Spirit (John 3:5). This spiritual baptism is necessary to put someone into the kingdom of God (God's church, the bride of Christ) and is evidenced by speaking in other tongues (other languages) as the Spirit of God give utterance.

It was prophesied by Joel (Joel 2:28-29) and Isaiah (Isaiah 28:11), foretold by John the Baptist (Matthew 3:11), purchased by the blood of Jesus, and promised by Him to His disciples (John 14:26; 15:16). The Holy Ghost was first poured out on the Day of Pentecost upon the Jews (Acts 2:1-4), then upon the Samaritans (Acts 8:17), and later upon the Gentiles (Acts 10:44-46; 19:6). "The promise is unto you, and to your children, and to all that are afar off, even as many as the Lord our God shall call" (Acts 2:39).

Tongues

Speaking in other tongues as the Spirit of God gives utterance is the manifestation God has given as the definite, indisputable, supernatural witness or sign of the baptism of the Holy Ghost (Acts 2:4; 10:46; 19:6). It was prophesied by the prophet Isaiah as the rest and the refreshing (Isaiah 28:11-12), foretold by Jesus as a sign that would follow believers of the gospel (Mark 16:17), and experience by Jews and Gentiles alike.

The gift of "divers kinds of tongues," mentioned by Paul in I Corinthians 12:1-12 and concerning which he gave regulations in I Corinthians 14:1-40, is given by both for self-edification (I Corinthians 14:4) and for the edification of the church (I Corinthians 14:27-28). In church meetings, the gift of tongues is used to give a public message, and it is to be interpreted. Since this gift can be misused in public, it needs proper regulation (I Corinthians 14:23-28). Not all believers exercise the gift of tongues, which is different in function from tongues given by God as the initial witness of the baptism of the Holy Ghost.

Paul said, "Forbid not to speak with tongues" (I Corinthians 14:39) and "I thank my God, I speak with tongues more than ye all" (I Corinthians 14:8). Who dares to teach or preach to the contrary?

Speaking in tongues means speaking miraculously in a language unknown to the speaker, as the Spirit gives utterance. Tongues can be classified in two ways, according to function: (1) speaking in other tongues as the initial evidence of the baptism of the Holy Ghost and (2) the gift of tongues as mentioned in I Corinthians.

Holiness

After we are saved from sin, we are commanded, "Go, and sin no more" (John 8:11). We are commanded to live soberly, righteously, and godly in this present world (Titus 2:12) and warned that without holiness no one shall see the Lord (Hebrews 12:14). We must present ourselves as holy unto God (Romans 12:1), cleanse ourselves from all filthiness of the flesh and spirit (II Corinthians 7:1), and separate ourselves from all worldliness (James 4:4). If the righteous scarcely be saved, where shall the ungodly and the sinner appear? (I Peter 4:18). No one can live a holy life by his own power, but only through the Holy Spirit. "Ye shall receive power, after that the Holy Ghost is come upon you" (Acts 1:8).

Divine Healing

God has made Himself known through the ages by miraculous healings and has made special provisions in the age of grace to heal all who will come to Him in faith and obedience. Divine healing was purchased for us by the blood of Jesus Christ, especially by His stripes (Isaiah 53:5; Matthew 8:16-17; I Peter 2:24).

Jesus went everywhere healing those who were sick (Matthew 4:23-24), and He commanded His disciples to do the same (Matthew 10:8). He said concerning those who believe the gospel, "They shall lay hands on the sick, and they shall recover" (Mark 16:18). Mighty healings and miracles followed the disciples wherever the gospel was preached.

There is no sickness or disease too hard for God. Any of us, our children, or our friends can be healed by the power of God. "Is any sick among you? let him call for the elders of the church; and let them pray over him, anointing him with oil in the name of the Lord shall raise him up: and if he has committed sins they shall be forgiven him. Confess your faults one to another, and pray one for another, that ye may be healed" (James 5:14-16).

Second Coming of Christ

Jesus Christ is coming back to earth in bodily form, just as He went away (Acts 1:11). He will catch away a holy people (His bride, His church) who have accepted redemption through His blood, by birth of water and of the Spirit, and who are found faithful when He comes.

"For the Lord himself shall descend from heaven with a shout, with the voice of the archangel, and with the trump of God: and the dead in Christ shall rise first: then we which are alive and remain shall be caught up together with them in the clouds, to meet the Lord in the air: and so, shall we ever be with the Lord" (I Thessalonians 4:16-17). "One shall be taken and the other left" (Luke 17:36). Will we be ready?

The signs of His coming are everywhere. The days of peril are here indeed, with forms of godliness void of the power of God; society and politics corrupted; and people's hearts filled with pride, blasphemies, unholiness, love of evil, and love of pleasures (II Timothy 3:1-13). These things, together with multitudes running to and fro, the increase of knowledge (Daniel 12:4), the persecution of the Jews and their return to Palestine (Luke 21:24), and scores of other things are starting signs that Jesus' coming is drawing near.

Wars, rumors of wars, famines, earthquakes, storms, floods, distress of nations, perplexity, and people's hearts failing them for fear are sounding the solemn alarm that Jesus' coming is at hand (Matthew 24:6; Luke 21:25-28). "Prepare to meet thy God" (Amos 4:12).

Resurrection

There will be a resurrection of all the dead, both just and unjust. "Marvel not this: for the hour is coming, in the which all that are in graves shall hear his voice, and shall come forth; they that have done good, unto the resurrection of life; and they that have done evil, unto the resurrection of damnation" (John 5:28-29). "And I saw the dead, small and great, stand before God ...and the sea gave up the dead which were in it; and death and hell delivered up the dead which were in them" (Revelation 20:12-13)> (See also Daniel 12:2; I Corinthians 15:13-23.)

Judgment

"It is appointed unto men once to die, but after this the judgment" (Hebrews 9:27). For this reason, there will be a resurrection for everyone. "For we must all appear before the judgment seat of Christ; that everyone may receive the things done in his body, according to that he hath done, whether it be good or bad" (II Corinthians 5:10).

The eternal destiny of every soul shall be determined by a just God who knows the secrets of everyone's heart. "And before him shall be gathered all nations: and he shall separate them one from another, as a shepherd divideth his sheep from the goats: and he shall set the sheep on his right hand, but the goats on the left. Then shall the King say unto them on his right hand, Come, ye blessed of my Father, inherit the kingdom prepared for you from the foundation of the world... Then shall he also say unto them on the left hand, depart from me, ye cursed, into everlasting fire, prepared for the devil and his angels... And these shall go away into everlasting punishment; but the righteous into life eternal" (Matthew 25:32-34, 41, 46).

VISITOR PROCEDURE

Visitors Are Welcome!

Because the safety of all EVAE community members is important to us, Early View Academy of Excellence requires that all visitors:

- 1. Use the designated entrance and Report to the Office/Security Desk.
- 2. Show some form of picture identification.
- 3. State the nature of the visit, obtain a visitor's badge by signing in on the EVAE Visitor Roster.
- 4. Wear/display the EVAE Visitor Pass while in the Academy.
- 5. Be escorted to the requested location.
- 6. Return the Visitor Pass to the Office/Security Desk and sign out.
- 7. For early dismissal or parent visits, scholars will be escorted to office.
- 8. Parent Conference with teachers will be scheduled after school.

PARENTS/GUARDIANS RIGHTS AND RESPONSIBILITIES

Early View Academy of Excellence (EVAE) recognizes that you as a parent or guardian are our most important partner in your child's education. Your involvement is essential to your child's educational success. We urge you to understand and exercise all your rights and responsibilities.

A. Parent/Guardian Bill of Rights

Regarding communication with Academy, you have a right to:

- Communicate with your child's teacher(s). They are the first level of contact. Advocate for your child and be shown respect.
- Visit the academy and classrooms to observe and to attend academy-related activities, including academy parent meetings and board meetings.
- Contact the administration if your child has been discriminated against or harassed in any way.
- Request a conference if you believe that an academy staff member has violated laws or EVAE policy.
- Request a conference be held as soon as possible with teachers and administrators to have curriculum, grades, testing, homework, and discipline explained to you.
- Receive regular reports of academic progress, attendance, and other concerns.

Regarding what your child is taught in Academy, you have the right to:

 Request a referral for Special Needs Assessment for your child if you suspect he/she has special needs.

Regarding your child's Academy records, you have the right to:

- Expect that information about your child be protected and treated as confidential.
- Examine and receive copies of entire child's Pupil Records.
- Ask that inaccurate or misleading academy records concerning your child be considered for correction or removal.

Regarding the discipline of your child, you have the right to:

- Appeal disciplinary actions, such as suspension, expulsion, assignment to another class or bus suspension.
- Appeals are submitted to administration in writing and will be acknowledged within business days.
- Request a conference with an administrator and/or designee to reduce the number of days of a suspension.

B. Notification of Parents/Guardian Rights Regarding Scholar Records

> Rights of Non-Custodial Parents:

If you are a non-custodial parent, you have the same rights to scholar records, progress reports, academy mailings, academy visits, and parent-teacher conferences as custodial parent unless a court order restricts such rights. It is your responsibility as a non-custodial parent to give the academy your address and contact information if you want to be consulted regarding your child and to be placed on the academy mailing list. Only the custodial parent can remove a child from the academy or give permission (in writing) for the child to be removed from the academy by another adult. Early View Academy does not interfere with custodial disagreements – we follow court orders.

> Rights of Foster Parents:

As a foster parent, you have **many of the same rights** as biological parents or legal guardians **for the duration of the child's placement in your home**. In some cases, however, law restricts these rights.

Rights of Parents of Children Suspected of Having Special Education Needs:

If you suspect that your child has special educational needs, you have the right to have him/her evaluated. Please contact Milwaukee Public Schools or the EVAE administration.

Release of Records to Other Schools:

Scholar records are released to other schools within five (5) days of EVAE receiving notice, from the new school, that the scholar has enrolled in another school.

Reporting Suspected Child Abuse or Neglect

The EVAE staff is required by State law to report suspected child abuse and neglect. Required reporting leads to protection for all our children and helps to identify supports for families who may need it.

EARLY VIEW ACADEMY OF EXCELLENCE SCHOOL COMMUNITY "CODE OF CONDUCT"

At Early View Academy, "EAGLES S.O.A.R. WITH P.R.I.D.E.!"

We the members of Early View Academy of Excellence School Community accept the Code of Conduct. We agree to relate to one another and to the Academy with <u>RESPECT</u>. We agree to <u>SOAR</u> and take <u>PRIDE</u> in all we do and say.

P.R.I.D.E. = (Personal Responsibility In Delivering Excellence)
S.O.A.R. = (Stand-tall On-task Attitude Respectful/Responsible)

RESPECT: We esteem others more highly than ourselves.

SOAR: We stand tall and remain on task. Our attitude is in check. We are respectful and responsible.

PRIDE: We take personal responsibility in delivering excellence. We take ownership for our learning and our school community.

Early View Academy of Excellence is committed to providing a safe and effective learning environment by recognizing that:

- Scholars have a right to learn, and teachers have a right to teach in a safe and orderly environment.
- No individual or group has the right to undermine the goal of providing a quality education for all scholars.

All scholars of Early View Academy must follow the Code of Conduct whenever:

- While on Academy grounds
- While going to or coming from Academy
- On the Academy buses (while on or off the premises)
- During Academy sponsored events (while on or off the premises)

Scholars are responsible for their own behavior and are expected to abide by the Code of Conduct, as well as by other school and classroom expectations that help maintain a positive learning environment. Scholars will:

- Follow all Early View Academy policies and the expectations of their classrooms.
- Work toward academic achievement by attending school and classes regularly, bringing classroom materials, including books, pencils, and paper, and completing all assigned class work.
- Respect the learning of ALL –Refrain from behaviors that distract others from learning.
- Respectfully and honestly communicate with ALL school community members—Refrain from foul language, sexual conversations, "ribbing" or bullying, or slang. "No Snitching" policy will not be tolerated, and scholars may receive consequences based upon withheld information. Refrain from

making threats of violence, joking about violence, or starting rumors of violence against the school, staff, or scholars. Such actions will be quickly and thoroughly investigated.

- Respectfully engage with others and demonstrate physical boundaries (The following pertain to all male and female, male and male, or female and female interactions) maintain a reasonable distance; no fighting or hitting, hanging on each other, shoving, wrestling, chasing, public displays of affection (kissing, holding hands, sitting on lap, hugging, etc) or any such behavior that interrupts learning environment; no sexual solicitation, sexuality identification or sexual preference discussions and/or requests ex: Asking about other's sexual orientation or sexual status, and/or requesting sexual favors.
- Respectfully resolve conflicts and disputes with others.
- Respect the rights and property of others while going to and from school, at all school-related activities, at bus stops, and on buses.
- Act responsibly with school property and replace or reimburse the school for lost or damaged school property, including books and equipment.

LUNCHROOM BEHAVIORS

Lunchroom procedures shall be set by supervising adult.

Scholars must say "please" and "thank you" to individuals who serve or assist them and clean up after themselves. After lunch dismissal, scholars are accountable to be in their next class on time.

CAFETERIA, CLASSROOM, HALLWAY BEHAVIORS

It is the scholar's responsibility to conduct themselves in an orderly manner in the cafeteria/halls and classrooms. Scholars are expected to walk on the RIGHT side of the hallway.

Scholars are expected to refrain from the following behaviors:

- Refusal to follow directions of the staff
- Throwing food or any other object
- Walking in and out of the assigned area without proper permission
- Littering
- Selling of outside food
- Eating or drinking food items in the halls or classroom (unless organized by a teacher)
- Gum chewing

Violations of the Code of Conduct that are dangerous, disruptive, or interfere with a teacher's ability to teach effectively will not be tolerated.

ACADEMY CLOSINGS/ NO SCHOLAR ATTENDANCE

Parents will receive reminders on a regular basis. Please check your child's book bag. This information will contain data regarding Academy closings and/or half days. Parents are encouraged to post this information in a visible location in their home.

The Academy's calendar is very different from MPS; however, when MPS cancels class for weather related reasons (snowstorm, extreme flood warning, etc.); the Academy will also be closed on that day.

Closings are communicated on Channel 4, 6, and 12. Parents may receive notification through our electronic calling system. In addition, if situation permits, there may also be a message on the Academy's messaging system.

ACADEMY HOURS Rev. 7/2019

WE VALUE EDUCATION AND WE START ON TIME!

The academic day at EVAE begins at 8:00 a.m. and concludes at 3:30 p.m., Monday through Friday for all scholars. Scholars are considered tardy/late at 8:20 a.m.

ATTENDANCE POLICY

Per Wisconsin Department of Public Instruction statute, as a private school, we are required to provide the following instructional hours:

- K4 at least 437 hours; In addition, 87.5 Parent Outreach Hours
- K5 at least 875 hours
- 1st 6th at least 1050 hours
- 7th 12th at least 1,137 hours

ABSENCES

In effort to deter scholars from missing school, all truancy violations are CUMULATIVE for one school year. Absences should be called into the Academy in advance.

In accordance with EVAE policy and considering child abduction and the importance of every minute in that situation, parents must contact the Academy whenever their child is absent. Parents may leave phone messages before 8:00 a.m. For those absences that are unexplained, a

follow-up call will be made by scholar services department to verify the reason for the absence. In addition to calling the Academy, written documentation from parents or guardians is required for all absences. The responsibility for regular Academy attendance rests on the scholar's parents/guardians. Each scholar is expected to be in Academy every day classes are in session. It is the responsibility of the parent to contact the Academy office to report absences and tardiness. State law requires that all children between the ages of six and 18 and graduated to attend school full time.

EXCUSED ABSENCES

Please note: More than three (3) excused absences may result in truancy.

*If a written excuse is used, make sure it includes the following information:

Scholar's full name and grade, a brief but full explanation for the absence and the specific day(s) covered by the absence.

Excused absences defined as: Illness or injury, quarantine; death in the immediate family; medical or dental appointments; court or administrative proceedings; religious observations; or educational opportunity (requires approval by principal prior to absence). Academy suspensions during the expulsion process, up to 15 days.

UNEXCUSED ABSENCES

You will be notified in writing of unexcused absences. Early View Academy imposes the following process for "unexcused absences":

- 3 unexcused absences = notification and mandatory meeting with Scholar Services
- 5 unexcused absences = notification and mandatory meeting with Administration
- 7 unexcused absences = notification and mandatory meeting with Board of Directors
- 10 unexcused absences = referral to District Attorney and recommendation to Board for Removal

Parents who fail to meet with administration and/or fail to correct the truancy problem, may warrant penalties which include referral to the Milwaukee County District Attorney's office for prosecution.

<u>Unexcused absences defined as</u>: All other absences are unexcused and unlawful for reasons other than those stated above. Truancy, vacations, no EVAE provided transportation, and no reason for absences are all considered unexcused absences. If a child is suspended from the bus and does not attend school, that absence is unexcused.

EARLY VIEW RESERVES THE RIGHT TO DROP SCHOLARS WHO ARE NOT IN ATTENDANCE FOR 10 CONSECUTIVE DAYS.

TARDINESS

If there is no medical documentation, parent must accompany the scholar into the office and speak to administration.

- 3 unexcused tardy = notification and scholar detention
- 5 unexcused tardy = notification, scholar detention, mandatory parent conference with administration
- Next unexcused tardy = notification, 1-day suspension, mandatory parent conference with administration
- Next unexcused tardy = notification, 3-day suspension, Behavior contract
- Next unexcused tardy = notification, referral to Board for Removal

EARLY DISMISSALS

It is imperative for the orderly operation of the Academy that all parents cooperate fully with the arrival and pick-up times. Parents should not arrive earlier than 15 minutes to remove their child from class unless they have notified the office in advance. If a child is to be sent home, parents must notify the Academy in writing or call the phone no later than 2:00 pm for early dismissal(s). Last minute calls/requests may not be honored.

LATE PICKUPS Rev. 7/2019

<u>Scholars not enrolled in the EV CLC</u> and not picked up at dismissal time will be taken to the office. If a parent is more than 10 minutes late picking up the scholar, a childcare fee of \$10 may be charged to the parent (this is an independent cost not covered by Choice). (Rev. 7/2019)

PRE-ARRANGED ABSENCES

If a scholar anticipates an absence, a written note by the parent/guardian indicating the dates the scholar will be absent must be submitted to the main office. Please note that absences have a detrimental effect on a scholar's accomplishment and progress.

SAME-DAY ABSENCES

Scholars who are suspended or have an unexcused absence from school are not allowed to attend or participate in any school-sponsored events (practices, athletic competitions, school parties/celebrations, theater performances, etc.) held on the day they were absent.

TRUANCY

Truancy is a major violation of Early View Academy of Excellence regulations. A scholar is considered habitually truant if he/she misses more than 3 full or partial days without a valid excuse per school year. Any scholar who misses school or a class without prior permission or who misses for reasons other than those outlined in the excused absence section may be considered truant. Scholars with excessive tardiness and excessive excused and unexcused

absences may be considered truant. The Academy has the authority to reject excuses that do not appear to be substantiated. Persons who engage in or cause habitual truancy may be referred to the Milwaukee County District Attorney's office for prosecution.

In an effort to deter scholars from missing school, all truancy violations are CUMULATIVE for one school year.

Assignments given that day may result in a zero. This includes tests and quizzes. Truancy can lead to suspension and/or expulsion.

COVID-19 SAFETY ADDITIONS

This section does not include all COVID-19 safety procedures and is subject to change:

- Masks are required at all times (unless otherwise instructed)
- Social Distance requirements are required at all times
- Scholars/parents with temperatures and/or symptoms will not be allowed on the bus and/or in the building (no exceptions)
- Scholars who develop/display any symptoms during the day must immediately leave the building (no exceptions)

CHAPEL SERVICES

Early View Academy is a Christian school and exercises chapel services which are held on a weekly basis. Scholars will be taught Biblical principles of living a Godly life. Parents are welcomed to attend these services.

DPI Private School Choice Program

The Milwaukee Parental Choice Program gives children from low-income families the opportunity to attend private schools. The state will pay the tuition of the child if the household income meets certain guidelines. All scholars must reapply for DPI Private School Choice Program every year.

All parents in the Choice Program are asked to comply with expectations and regulations regarding fund-raising, parent meetings, and parent-teacher conferences. *The State (DPI)* provides a brochure which answers frequently asked questions, see staff for a copy. If a parent has additional questions, which are not addressed in this handout, please contact the Academy.

CHOICE APPEALS PROCESS

The following is Early View Academy of Excellence's policy adopted by our governing body to satisfy the requirements of 119.23(6m) (a) (4).

Under 119.23(2) (a) a pupil must reside in the city of Milwaukee and meet the income requirements defined below to qualify for the MPCP:

The pupil is a member of a family that has a total family income that does not exceed an amount equal to 1.75 times the poverty level determined in accordance with criteria established by the director of the federal office of management and budget. A pupil attending a private school under this section whose family income increases may continue to attend a private school under this section if the pupil is a member of a family that has a total family income that does not exceed an amount equal to 2.2 times the poverty level determined in accordance with criteria established by the director of the federal office of management and budget. For purposes of admission to a private school under this section, siblings of pupils attending a private school under this section are subject to the higher income limit. If a pupil attending a private school under this section, the lower income limit applies unless the pupil is a sibling of a pupil attending a private school under this section."

119.23(3) (a) states that a school must, "Within 60 days after receiving the application...notify the applicant, in writing, whether the application has been accepted. If the private school rejects an application, the notice shall include the reason." A school may only reject an applicant for not meeting income and residency requirements, or for losing a random selection lottery.

Under Early View Academy of Excellence's appeals process, a rejected applicant has five working days from the date of receipt of their notice of rejection to provide written evidence to the Governance board that the applicant was improperly rejected. The evidence must include income and residency documentation. The Board president or principal shall respond to the applicant's appeal within five working days of receipt of the appeal notifying him or her of the acceptance or rejection of the appeal.

Early View Academy of Excellence is a private Academy that accepts scholars with tuition assistance, such as the Milwaukee Parental Choice Program (MPCP). Early View Academy of Excellence reserves the right to pursue legal action against the parent, guardian, or agency for reimbursement of tuition cost if parent/guardian is found ineligible for Milwaukee Parental Choice Program or any other tuition assistance.

CLOSED CAMPUS POLICY

All scholars are required to stay on campus upon arrival, via school transportation, by parent or by foot. If it is necessary to leave the campus for appointments or reasons of illness, all scholars who are leaving campus must have an approved parent/guardian check out him/her through the office. Scholars will not be allowed to leave campus with any persons other than parent/guardian without parent/guardian permission. Administrators are the only individuals authorized to grant permission to leave outside of the parent. During a student's lunchtime, parents are allowed to bring lunch ONLY for their son/daughter. Food delivery (i.e., Doordash, Uber Eats, etc.) for students is strictly prohibited.

DISCIPLINE

Teachers, administrators, and other school personnel may take disciplinary action against EVA Scholars who break expectations. Disciplinary actions are set according to federal and state laws, and EVA administrative policies. **NOTE: ALL scholars including, exceptional and disabled scholars are subject to disciplinary procedures.**

PROGRESSIVE DISCIPLINE PROCESS

It is vital for parents and scholars to realize that maintaining an orderly atmosphere is critical to the learning process. Although it is necessary to set and enforce expectations and boundaries, it is our desire to train scholars to become self-disciplined. We want to encourage our scholars to obey God and from that obedience to exhibit respect, care, and love towards others.

At Early View Academy of Excellence, we promote an environment that positively reinforces respect and PRIDE (Personal Responsibility in Delivering Excellence). EVAE values growth and therefore disciplinary actions will be documented in the scholar's official record. We recognize that some discipline will produce no immediate results in the heart of a scholar, but we hold to the truth of Hebrews 12:11, which states, "No discipline seems pleasant at the time, but painful. Later on, however, it produces a harvest of righteousness and peace for those who have been trained by it."

Teachers will discuss a scholar's misconduct with the scholar. Teachers will document in writing the use of discipline and may report disciplinary measures to the child's parent. Parents are advised to consult the scholar contract for discipline details.

The following steps will be followed when discipline is needed:

- 1) Teacher/Scholar Contact Verbal warning, Chance for scholar redirection
 - o Consequence Given by Teacher Discussions, reflections, detentions, etc.
- **2) Separation from class** Placed in another classroom to provide another opportunity for scholar redirection
 - Consequence Given by Teacher –Reflections, writings, detentions, etc.
 - Behavior Intervention Specialist Temporary removal and parent contact
- 3) Parent/Teacher Contact
 - o Consequence Given by Teacher Detention, incident referrals, duties, etc.
- 4) Referral to Administration for Intervention/Conference
 - Consequence Given by Administrator:
 - Detention
 - Suspension Out and/or in house (depending on infraction)
 - Recommendation for Behavior Contract
 - Recommendation for Expulsion (Chronic repetition of non-compliance)

LEVELS OF CONSEQUENCES

Consequences may be positive or negative and are intended to be in direct connection to the behaviors being addressed. Early View Academy has levels of disciplinary consequence for violations of Academy policy. Whenever possible, disciplinary action is to be handled by the classroom teacher. If the scholar is unresponsive, if there is repeated offense, or if the violation is severe, the administration may determine the appropriate level of consequence, and may accelerate the process through these levels of action should the scholar behave in ways clearly beyond normal limits of what is proper. The administration retains the right to suspend or recommend expulsion of a scholar as it deems necessary.

• **LEVEL 1: WARNING** - Each teacher will manage their classroom in an orderly way and clearly communicate expectations to scholars. Minor infractions in the classroom or hallways, etc. will be handled by the teacher responsible (Example: scholars running in the hall are asked to go back and start over, scholars littering trash are asked to clean the classroom.).

If a scholar repeats a minor infraction enough, weightier consequences may be offered.

- **LEVEL 2: DETENTIONS** —The purpose for in-house school-day detention is the following:
 - 1. To calm a student down
 - 2. To re-direct/refocus a student's behavior
 - 3. Re-incorporate a student to the classroom

• LEVEL 3: SUSPENSION Rev. 7/2019

Administration reserves the right to suspend, and send home scholar immediately, for a disciplinary infraction and/or consistent or serious disregard of any Academy policy. Suspension requires that a scholar remain off campus under his or her parent's supervision for one or more days as a disciplinary consequence. Reentry into the Academy after such a suspension will require a conference. Conferences will require these parties in attendance:

- Suspension #1, #2 administration or administrative designee, parent(s), scholar, and teacher(s).
- Suspension #3 administration will consider probable recommendation for expulsion from Academy.

The following choices will warrant suspension from Academy (list is not exhaustive):

- a. Any form of disrespect to authority: non-verbal and verbal
- b. Insubordination (refusal to comply with directives)
- c. Repeated noncompliance with Academy Policies
- d. Receive 2 or more afterschool detentions within a quarter
- e. Repeated lying, cheating, stealing, or using vulgar language

- f. Leaving the premises without permission
- g. Violation of Harassment/Bullying Policy, includes hazing (ex: "21"), bullying and/or cyberbullying of scholar or staff members (Rev. 7/2019)
- h. Activities that occur off campus but disrupts the learning environment (Rev. 7/2019)
- i. Videotaping and/or postings scholars, staff, or Academy activities without Academy approval, while on or off campus, or school sponsored (*Rev. 7/2019*)
- j. Extortion, intimidation, or disrespect of another scholar or staff member includes verbal, written and/or electronic defamation of character for any scholar, staff member or the Academy (e.g., social media) (*Rev. 7/2019*)
- k. Impersonation of a Parent/Guardian (telephone, verbal or written)
- I. Throwing objects
- m. <u>Weapons:</u> NO WEAPONS ALLOWED ON ACADEMY GROUNDS, ON ACADEMY BUS, IN THE ACADEMY BUILDING, SURROUNDING THE ACADEMY. EXPULSION WILL RESULT AND POLICE WILL BE CALLED.

During the suspension, the scholar is prohibited from being on Early View Academy of Excellence property during the Academy day or during any Academy sponsored activity.

DUE PROCESS

Scholars who are suspended may appeal their disciplinary action. Appeals are handled by the administration. Parents may contact administration, within 24 hours of the decision, and must state the basis for appeal. Administration may gather such information and speak with such individuals as he or she deems appropriate and may consult before reaching a decision. Administration's decision is final and binding.

• LEVEL 4: EXPULSION

Expulsion is the legal termination of a scholar's privilege to attend Academy. Under Wisconsin state law, all scholars are required to attend school until they reach 18 years of age or when their high school class graduates. Scholars can be suspended for a maximum of 7 days, before a determination is made to seek expulsion. Administration reserves the right to expel a scholar and/or request an expulsion hearing before the Board of Trustees. Early View Academy of Excellence reserves the right to pursue legal action against parent/guardian if outstanding financial obligations have not been met and/or all Academy property returned in good condition. Upon the discretion of Administration, expelled scholars may or may not complete mid- and/or final exams, testing, etc. Any expelled scholar may not be on Early View Academy of Excellence property (during Academy or Academy functions) or be present at Early View Academy of Excellence functions without permission of Administration. Expulsion is the final step of discipline at Early View Academy of Excellence and therefore a scholar that has been expelled will not be allowed to return as a scholar without Board approval (list is not exhaustive) Rev. 7/2019

The following choices will warrant expulsion from Academy (list is not exhaustive):

- 1. Repeated noncompliance with Academy Policies
- 2. While on school property, or within 300 feet of school property, as measured from any point on the school's real property boundary line, or while attending a school-sponsored or school-related activity on or off school property, commits certain offenses and misconduct, specifically:
 - (A) Violation of Weapons Policy uses, exhibits, or possesses:
 - (1) a firearm.
 - (2) an illegal knife.
 - (3) a club; or
 - (4) a weapon listed as a prohibited weapon under "Weapons Policy".
 - (B) engages in conduct that contains the elements of the offense of:
 - (1) aggravated assault.
 - (2) aggravated sexual assault.
 - (2) arson.
 - (3) murder.
 - (4) indecency with a child underage.
 - (5) aggravated kidnapping.
- 3. Commission of a felony
- 4. Extortion, intimidation, or disrespect of another scholar or staff member includes verbal, written and/or electronic defamation of character for any scholar, staff member or the Academy (e.g., social media) (*Rev. 7/2019*)
- 5. Videotaping and/or postings scholars, staff, or Academy activities without Academy approval, while on or off campus, or school sponsored events. (*Rev. 7/2019*)
- 6. Engaging in inappropriate physical or sexual conduct
- 7. Engaging in conduct that constitutes sexual harassment, including but not limited to verbal or physical conduct of a sexual nature
- 8. Violation of Drug Use Policy Possession of Tobacco, Alcohol, Drugs, or Drug/Tobacco Paraphernalia or any other Controlled Substance (allegation, participation with, possession and or use) may also include informing local authorities (MPD)
- 9. Assault of, or threats to, another person, including any physical, verbal, cyber, emotional, and written forms
- 10. Violation of Harassment/Bullying Policy, includes hazing (ex: "21"), Bullying and/or cyberbullying of scholar or staff members (Rev. 7/2019)
- 11. Gang Activity
- 12. Possession or sale of stolen property
- 13. Possession or use of matches or a lighter, except as part of an instructional program.
- 14. Activities that occur off campus but disrupts the learning environment (Rev. 7/2019)
- 15. Providing a negative example to the other scholars
- 16. Creating a dangerous and unsafe environment for scholars or school personnel

Re-admittance to the Academy community during the following year will be considered on a case-by-case basis. It requires genuine repentance and change of heart as evidenced by the following:

- Sincere reflection and apology for offense(s)
- Formal Behavior Contract signed by parent, scholar, and administration enforced for the duration of the Academy year.
- Letter of recommendation from previous school (if applicable)
- Creation and implementation of a Corrective Action Plan
- Board Approval

DUE PROCESS

Scholars who are expelled may appeal their disciplinary action. Appeals are handled by the Board liaison and/or Board representative/designee. Appeals must be submitted in writing to the Board, within five (5) days of the decision, and must state the basis for appeal. The Board may gather such information and speak with such individuals as he or she deems appropriate and may consult before reaching a decision. The Board's decision is final, legal, and binding.

SCHOOL BUS DISCIPLINE Rev. **7/2019**

School bus transportation is a privilege not a right. Parents will be contacted if the Academy receives a report of scholar misconduct while on the school bus. The Transportation Manager, Administration and/or designee reserve the right to suspend and/or revoke transportation privileges for misconduct. Parents are responsible for providing transportation for scholars not using EVAE transportation for any reason including bus suspension, after school detention, missed bus, etc.

Consequences for misbehavior (determined case by case), include but are not limited to:

- Warning/Redirection
- 1-day suspension
- 3-day suspension
- 5-day suspension
- Revocation of bus privileges for an extended period or for rest of school year

USE OF PHYSICAL FORCE AND/OR RESTRAINT

Academy officials as allowed by law may use physical force and/or restraint. Examples include stopping a disturbance, preventing injury to self and others, protecting property, or removing a disruptive scholar from the classroom, Academy building or Academy-related activities. Administration and/or designee reserve the right to involve the authorities prior to contacting parents. The Academy reserves the right to pursue legal action.

DRESS CODE POLICY

Early View encourages a tasteful lifestyle, self-discipline, and the continuing individual growth of staff and scholars. The purpose of the dress code is to promote a sense of unity, discipline, and professional expectation within our school community. Early View Academy requires ALL scholars in grades K- 12th grade to wear proper uniform every day AND are required to maintain uniforms, shoes, and personal appearance in a clean and presentable way throughout the school day and whenever on campus. That means that scholars must keep his/her shirt tucked in and maintain a neat, clean appearance before, during and after school. Scholars who arrive to school without proper uniform may not be allowed into the classroom until the proper attire presented by parent, or they may be sent home.

Repeat violations will warrant the parent conference and other school issued consequences.

Listing of Acceptable Clothing

Traditional Dress Code

The Dress Code does not allow for <u>clothing</u> with colored trim, stripes, embroidery, decoration, etc. It also does not provide overalls (overalls with pants or shorts), sweatpants, knit pants/ skirts, sheer clothing, leggings, etc. A small logo is acceptable on otherwise approved clothing items.

Beginning September 1, 2021, lady scholars are able to wear Khaki pants (not joggers, not capripants, etc.).

Hair:

- Boys: Clean, cut or braided and shaped.
- Girls: Clean, cut or braided and styled
- Bottoms: Navy or Khaki Tan
 - Slacks, Skorts, Skirts, Skirted jumpers
 - o Must be plain, solid-color Twill, Polyester or Corduroy fabric
- Tops: White, navy, light yellow or light blue with collar
 - Must have long or short sleeves
 - Knit polo-type, Oxford or woven dress shirts, blouses, turtlenecks
- Shoes:
 - Black, navy, brown dress, or casual shoe
 - White, navy blue or black tennis shoes (low top) with non-marking soles (No outlandish colors)

Hosiery:

- Girls: Choice of Solid white or navy (leggings to ankles, knee-high socks, tights, or white/navy blue/black/flesh colored panty hose)
- Boys: Choice of Solid white, navy or black

Other dress code expectations:

- O A BELT IS REQUIRED FOR ALL SLACKS.
- O SHIRTS (INCLUDING T-SHIRTS) MUST BE TUCKED IN.
- **O SKIRTS MUST BE KNEE LENGTH.**
- o Shoes must be safe and appropriate no toe out, sandals or boots
- Bottom garments worn at scholar's waist.
- o Clothing that is sheer, too tight, too loose, or too revealing is not appropriate for school

OCTOBER 1st THROUGH MARCH 31st

 Scholars should wear Solid navy-blue sweater (pullover, vest, or cardigan) OR Solid navy-blue blazer DAILY. Sweaters or blazers should have a collar OR be worn with a collared uniform shirt and should not have any colored trim, stripes, decoration, etc. (small logos are OK)

DECEMBER 1st THROUGH MARCH 31st (Inclement Weather Dress Code)

On very cold days, scholars who walk or stand on bus stops, etc. may need to wear additional clothing under uniform on their way to/from school. However, any clothing that doesn't meet dress code requirements must be removed before school begins.

LISTING OF UNACCEPTABLE ITEMS

Administration reserves the right to determine if any fashion, fad, hair, jewelry, or article of clothing is appropriate for school and complies with school expectations. These decisions will be made on an individual basis.

The following items are restricted from the dress code:

- Distractive Makeup: (subject to the interpretation of administration)
- Distractive Hairstyles: unnatural hair color, outlandish hair cut styles with words or symbols, colorful weave outside of natural hair color, (subject to the interpretation of administration)
- Body Piercing (ex: tongue rings, nose rings, eye rings, cheek, or lip rings, etc.)
- Distractive Jewelry: multiple bangles, chains, necklaces, multiple earrings, large hoop earrings, mouth "grills", etc. subject to the interpretation of administration
- Distractive Accessories: colorful weave
- Female scholars should not wear more than 2" heels
- Showing of tattoos
- No non-religious head gear. (religious gear must be substantiated)

EVAE SCHOOL "PRIDE" GEAR

As part of our mission to hold ourselves and our scholars to standards of excellence, Early View celebrates school PRIDE (Personal Responsibility for Delivering Excellence). All scholars will be permitted to wear an EVAE t-shirt or sweatshirt with uniform bottoms.

GYM UNIFORM

Grade 6th – 12th: Uniforms are required. Gym uniform includes navy blue t-shirt, shorts (to the knee), or jogging pants. Scholars who are not in uniform on physical education days will affect daily grade. Continual non-compliance will result in failing grade for physical education and administrative consequence. **Kindergarten through** 4th **Grade**: Uniforms are not required. However, female scholars should wear shorts under skirts on physical education days.

FIELD TRIPS

Field trips are a wonderful way of providing scholars with a stimulating, interactive learning experience. Parents are always welcomed to accompany their child on a field trip.

Alternative assignments are usual and expected for scholars who do not attend a field experience with their class or group. However, for safety of all scholars, the Administrator(s) reserve the right to require parent/guardian supervision for scholars with disruptive and/or challenging behaviors. Parents may be subject to pre-screened background checks. Parents are only allowed to chaperone their son/daughter.

All parents/guardians are required to sign a release of liability for all field trips during enrollment, which is also placed on the permission slip notifications, and states, "I, (name of parent/guardian), hereby voluntarily and absolutely releases, discharges, waives, and relinquishes any loss or damages or actions or causes of action for personal injury, property damage or wrongful death occurring to the scholar(s) as a result of his or her participation in the field trip activity." Failure to sign the permission slip will result in the scholar not being able to attend the trip. Hand-written permission slips are unacceptable.

FUNDRAISERS

Tuition covers only part of the cost of educating each child. For this reason, fund-raisers are a very necessary part of maintaining daily operations. There are two major fund-raisers held each year. One is held in the early fall and the second one held in the spring. Parents are encouraged to assist in planning and implementing these fund-raisers. The other alternative to satisfying the fund-raising obligations is to pay the equivalent sum in the form of a donation.

We do not participate in an honor roll system; however, we do acknowledge proficiency levels and growth on a quarterly basis.

INCOMPLETE GRADES

At the end of each quarter or semester, a grade of 'I' may be given in a course for a scholar as a temporary grade, when unavoidable medical, family, or personal hardships beyond the scholar's control has arisen in his/her life during the grading period. If the work is not made up within the designated time (the standard period is two weeks) by the scholar, the scholar's grade will be changed from 'I' to 'F' on the official record. As quarter and progress report grades are advisory only (not appearing on an official transcript), incomplete 'I' grades are rare and require the approval of the teacher and an administrator.

GRADING – K4-8TH

Early View Academy of Excellence issues quarterly grades for scholars in $K4 - 12^{TH}$ Grade. Grades K4-8 have a "standards based" grading system, which means that it reflects their level of proficiency with Wisconsin Common Core State Standards. Grades are comprised of 70% summative assessments and 30% homework, participation, and observations.

Grades are comprised of 70% summative assessments and 30% homework, participation, and observations. PLEASE NOTE: TO RECEIVE CREDIT FOR ANY COURSE – HS Scholars must receive a "D-" or above.

ACHIEVEMENT GRADE

Plus (+) and minus (-) signs after a grade indicate high or low scholar performance within the specified range. The scholar's Grade Point Average (GPA) is calculated on a 4-point system in which the following numerical values are assigned to letter grades:

Grades are indicators of scholar initiative, attitude, work ethic, and cooperation. The key to better grades is directly related to scholar effort.

FAILING COURSES

The "F" grade means the scholar has failed the class and is NOT acceptable as credit towards progression or graduation. Scholars who fail a course are expected to make-up the credit by taking an equivalent course in its place. SCHOLARS WHO MERELY ATTEND CLASS AND MAKE MINIMAL EFFORT TO ACCOMPLISH TASKS SHOULD EXPECT TO FAIL THE CLASS. Scholars who do not participate in class, may be considered a disruptive influence on the learning environment, and may be removed permanently from the class with a failing grade.

GRADE PROMOTION AND RETENTION Rev. 7/2015

A scholar may be retained if they fail to demonstrate academic proficiency in core academic areas. Throughout the year parents will be notified of their child's progress through two progress reports and four report cards. Scholars who are at risk of grade retention are given a minimum of three academic intervention letters per year. In addition, discussions will be held during Parent/Teacher Conference to discuss academic and behavior performance. Lack of academic progress may result in grade retention. Poor school attendance may result in grade retention.

PROMOTION OF GRADES 4TH AND 8TH

Scholars in grades 4 and 8 will be promoted or retained based on them meeting one or more of the three criteria in each of the six content areas.

Criterion #1

1. Academic Performance on Classroom Assessments Based on Standards: A scholar must receive a passing grade in core subject areas to be promoted at the fourth and eighth grade levels. The core area subjects are math, science, social studies, and reading/language arts. If a scholar does not demonstrate proficiency in academic performance, results of the Wisconsin standardized testing are the next criteria used for promotion or retention decisions.

Criterion #2

2. Wisconsin Standardized Testing Results (FORWARD, etc.): Scholars in fourth and eighth grade will be promoted if they score at the "Proficient" level on the math and reading subtests of the Wisconsin FORWARD exam. For scholars not achieving promotion, through classroom assessments or Wisconsin standardized testing, promotion or retention decisions are based on teacher recommendations.

Criterion #3

- **3. Teacher Recommendations:** A scholar may be promoted based on the recommendation of a building level team. This recommendation shall be based solely on the scholar's academic performance. At the minimum, this team shall consist of the building principal, teachers, counselors, parents/guardians, and other appropriate professional staff. This team can consider some or all of the following:
 - a. Written recommendations regarding the scholar's readiness to be advanced to the next grade from teachers having responsibility for core area subjects.
 - b. A portfolio of scholar generated materials assembled by the parent/guardian illustrating achievement of grade level academic objectives.
 - c. Other academic criteria as outlined below, if appropriate.

Criterion #4

4. Other Academic Criteria

The building principal may consider other academic criteria such as the scholar's grades in non-core subjects, daily assignments, cognitive ability, school attendance, previous retentions, and experiential background. The progress made on goals outlined in a scholar education plan by scholars with learning disabilities and scholars with 504 plans may also be considered.

EXCEPTIONS FOR SCHOLARS WITH DISABILITIES

Scholars with disabilities who do not meet the criteria for promotion may be promoted if the scholar's IEP team determines the child has achieved the objectives as outlined in his/her current Individual Education Plan (IEP).

PARTICIPATION IN THE WISCONSIN FORWARD EXAM

Pursuant to state statutes, a pupil's parent or guardian shall have the right to excuse their child from taking the Wisconsin Forward Exam. If a scholar is excused from the Wisconsin Forward Exam, the decision to advance the scholar will be based on academic performance, teacher recommendation, or other academic criteria (as outlined above).

GRADE PROMOTION AND RETENTION – HIGH SCHOOL Rev. 7/2015

Throughout the year teachers will inform parents of their child's progress by utilizing Midterm reports, phone calls, and other forms of notification. When there is a possibility a child may not be promoted to the next grade, a conference will be scheduled.

Scholar retention results when an EVAE scholar must repeat a grade level due to poor academic

performance. The Early View Academy of Excellence instructional staff and administration may retain any scholars who fail to demonstrate academic mastery in core subject areas. Retained scholars may be required to repeat specific classes or an entire grade level depending upon the individual scholar's performance. EVAE may retain any scholar who fails both semesters of a core academic class in any high school grade

CREDIT RECOVERY

Currently, Early View offers online credit recovery during school hours as a part of the high school schedule. However, it is the responsibility of scholars to compete the online courses.

HIGH SCHOOL GRADUATION REQUIREMENTS Rev. 7/2015

POLICY FOR GRANTING A HIGH SCHOOL DIPLOMA

Early View Academy of Excellence will issue a high school diploma or certificate to each scholar, including those with special needs, who demonstrate the following:

- 1. Attends and has satisfactorily completed the course requirements and other requirements necessary for high school graduation:
 - Completion of minimum of 19 high school credit requirements; 15 units in core academic areas (see page 35)
 - Completion of culminating project presented to a panel of evaluators (must demonstrate proficiency in the integration of technology, career exploration, research, performance, writing and communication)
 - 60 community service hours.
- Criterion #1 Academic Performance on Classroom Assessments Based on Standards: A
 scholar must receive a minimum of "D" passing grade in subject areas to receive credit. If a
 scholar does not demonstrate proficiency in academic performance, results of the
 Wisconsin standardized testing are the next criteria used for decisions for granting
 diplomas.
- 3. Criterion #2 Wisconsin Standardized Testing Results (Forward, ACT Aspire, ACT, etc.): Scholars must score a minimum level of "Proficiency" in English/Language Arts and Reading or "Basic" in other subjects to receive a high school diploma. Scholars not achieving proficiency through classroom assessments or Wisconsin standardized testing, decisions may be based on teacher recommendations.
- 4. **Criterion #3 Teacher Recommendations:** A scholar may receive a high school diploma on the recommendation of a building level team. This recommendation shall be based solely on the scholar's academic performance. At the minimum, this team shall consist of the

CULMINATING PROJECT

To support our vision to produce lifelong learners ready for college and career, graduating scholars must demonstrate proficiency within the core curriculum and provide evidence of learning and personal growth through the integration of technology, career exploration, research, performance, writing and communication.

GRADUATION CEREMONY

The privilege to participate in the graduation ceremony is granted to scholars by Administration. Therefore, high school seniors that violate an Academy policy may be withheld from participation in the graduation ceremony. This policy is in effect up through graduation day. All graduation requirements must be met to participate in the graduation ceremony.

IMMUNIZATION REQUIREMENTS AND INFORMATION

IMMUNIZATION RECORDS ARE REQUIRED FOR ALL SCHOLARS.

Wisconsin requires that parents/guardians of all public and private school scholars in Pre-Kindergarten to Grade 12 give their school written evidence of immunization. The law requires that scholars receive a minimum number of immunizations <u>PRIOR</u> to entering Academy. To obtain proper immunizations, call your doctor, health center, or the Milwaukee Health Department. When your child is immunized, provide the records to Scholar Services Department.

MATERIALS FEE

All learning materials, including curriculum books and supplemental materials are the sole property of Early View Academy of Excellence. As a general practice, we do not charge an upfront book fee. However, we reserve the right to a charge parents/guardian for damaged Academy property, which includes physical property and all educational materials. Parents will be required to sign a "Book Release form" at the beginning of school to ensure compliance.

MEAL PROGRAM

Make sure your child has nutritious well-balanced meals at home. Your child's diet plays a significant role in his/her overall brain development, energy level and overall health. If possible, provide your child with a good breakfast in the morning. Breakfast will give your child the calories and energy he or she will need for a busy day.

- Breakfast and lunch are provided for our scholars at specified times to accommodate our scholars and our instructional scheduling.
- No containers/bottles that are opened will be permitted in the Academy!

NATIONAL SCHOOL LUNCH PROGRAM (NSLP)

All parents must complete a free or reduced-price meal program application as part of the registration process. If a family does not qualify for reduced or free lunch at the beginning of the Academy year, they should re-apply if their financial situation changes.

Scholars who bring their bag lunches WILL NOT have access to a means of cooling or warming their food. The Academy encourages scholars to eat nutritious lunches and <u>prohibits</u> the following: candy, gum, soda, and other junk food items even if it is a home provided lunch.

Parents who would like to bring birthday cake and ice cream (NO FOOD ITEMS) to the class should do so during an assigned time, not during lunch hour. Please contact the office to get approval from administration PRIOR to the event.

<u>Special Note for Lunch</u>: <u>Scholars have a limited time for lunch and are not permitted to leave</u> <u>campus during lunch</u>. Lunch brought to Academy for scholar must be eaten during regularly

scheduled time periods and must comply with the National School Lunch Program. Refrigeration and microwaves are not available for scholar lunches. (see page 14)

MEDICAL INFORMATION

In addition to the registration form, parents will also need to provide a copy of medical information form. The medical information form should provide a complete medical profile of your child including any allergies or health risks your child may possess.

In addition, parents will be asked to provide the Academy with a list of names and phones numbers of individuals who can be contacted in the event of a medical emergency. These individuals will be notified only if the parent cannot be reached by phone. If the parent and the emergency contacts cannot be reached, the paramedics will be called to assist with a medical emergency. Cost of paramedics will be assessed to the parent. **EMERGENCY CONTACT INFORMATION IS REQUIRED FOR ALL ENROLLED SCHOLARS.**

Parents of scholars diagnosed with any type of communicable disease must notify the Academy office within 24 hours of diagnosis for attendance record keeping. **Scholar should not attend without release from a physician.**

MEDICATION DISTRIBUTION

It is best to give your child any prescription medicine at home. However, at times a child may need to be given prescription medication during Academy hours. Academy personnel will only monitor self-medication of scholar. We <u>will not</u> administer medication of any kind. The EVAE policy on medication applies to scholars of all ages.

Parents must sign a consent form before Academy officials can supervise any self-medication of a scholar; this includes aspirins and other over the counter medications. If a scholar is taking a prescribed drug, the parent must provide a written copy of the instructions from the physician. The medication must be in an original pharmacy container identifying pharmacy, date the prescription for the medication was filled, name of the child, the physician, the name of the drug and the dosage to be administered.

If prescribed medication is to be discontinued, the parent must bring in the medical order signed by the child's physician. If changes are made, such as dose or time the dose is given, a new form must be completed and signed by the doctor.

Parents are responsible for ensuring that the medication is delivered to the Academy safely and that there is enough medication to follow the doctor's orders. An adult must deliver medications classified "controlled substance".

SCHOLAR ORGANIZATIONS

Scholar activities require scholars to sign up, parent permission, and academic/behavioral eligibility (some activities require proof a physical exam). Some activities may require uniform fees, additional materials, and firm time commitments. Each activity will provide a schedule of activities.

SCHOLAR RECORDS

Pupil Records means all records relating to individual pupils maintained by the school but does not include records maintained for personal use by a teacher or other person who is required by the state superintendent under s. 115.28 (7) to hold a certificate, license, or permit, if such records and notes are not available to others, nor does it include records necessary for, and available only to person involved in the psychological treatment of a pupil.

REPORT CARDS

Distributed to parents four times per year at the end of the quarter point. These reports are intended to inform parents and the scholar of the scholar's academic record, attendance, courses, required under the state law and records of the pupil's school extracurricular activities and behavioral incidents. Within the Report Card teachers may offer observations and suggestions on how the scholar may improve his/her grade in the class.

PROGRESS REPORTS

Mid-term report generated to inform scholars, parents/guardian of the academic progress of the scholar mid-quarter while there is still adequate time for the scholar to make improvements, if necessary.

Early View Academy maintain progress records for each scholar while the scholar attends the Academy and unless the Academy ceases to operate, for at least 5 years after the scholar ceases to attend the Academy. Upon request, Early View Academy provides a scholar or the parent or guardian of a minor scholar who is attending a copy of the pupil's progress records. Progress records mean those pupil records which include the pupil's grades (such as report cards), a statement of the courses of the pupil has taken, the scholar's attendance record, the scholar's immunization records, any lead screening records required under the state law and records of the pupil's school extracurricular activities. Early View Academy ensures that an accrediting agency reviews and reports to the DPI on its compliance with this provision. All records are confidential, except as provided in pars. (a) to (m) and sub (2m) of the above cited law.

TRANSFER OF RECORDS TO ANOTHER SCHOOL

Early View shall send Pupil Records to another school or school district within 5 working days of receiving written notice from any of the following (a) pupil, if adult, or the parent or guardian of a minor pupil that intends to enroll in another school; (b) a school or school district where a pupil has enrolled, and (c) a court that placed the pupil in a juvenile correctional facility or a secured residential care center for children and youth.

School and school districts are also defined to include any juvenile correctional facility, secured residential care center for children and youth, adult correctional facility, mental health institution, or center for the developmentally disabled, that provides an educational program for its residents instead or in additional to that which is provided by public and private schools.

TRANSFER OF RECORDS IF EARLY VIEW CLOSES (CEASES TO OPERATE)

In case the academy ceases operation, all records of MPCP and other scholars are transferred immediately to MPS (Milwaukee Public Schools Records), and a notice will be sent to each pupil or the parent or guardian of a minor pupil, and adult scholars (using the last address of record), that records have been transferred to MPS. (See attachment for sample letter)

SCHOLAR TRANSCRIPTS

EVAE will provide, at the scholar/parent/or outside agency request, transcripts of the scholar's grades for a fee of \$7.00. Agencies/Schools requesting scholar transcripts through a formal request will be issued transcripts free of charge. Requests should be submitted to Scholar Services at least 48 hours before transcripts are required.

SPECIAL EDUCATION

Early View Academy of Excellence does not have a Special Education Program. The Academy is committed to assisting identified special education scholars in overcoming their educational barriers by providing a supportive environment for them to learn. Therefore, we strive to make accommodations for learning disabilities in a regular education setting.

In the event, a child is not able to work within the regular classroom setting, the parents will be contacted by administration and other educational options may be presented. Examples of such behaviors that may prohibit inclusion would be, but not limited to:

- Poor peer relationships or social skills
- Violent behaviors towards peers or teachers
- Severe academic deficiencies

TRANSFER SCHOLAR/TRANSFER HIGH SCHOOL CREDIT

Early View Academy of Excellence will consider accepting school credit from other institutions to the extent that coursework at the previous institution is documented and in accordance with Early View Academy of Excellence's academic standards as adopted under Early View Academy of Excellence's Pupil Academic Standards. All final determinations for the acceptance or rejection of transfer credits shall be made at the discretion of administration.

A scholar transferring into the Academy shall be placed at the appropriate grade and course level. Early View Academy determines placement of a scholar. An official transcript must either accompany registration OR be presented within seven (7) days from the scholar's first day of attendance. If no transcript is located or found, Early View Academy determines placement of a scholar by form of assessment. Transfer credit is only awarded for high-school level courses. No more than 1.0 credit will be recorded on the scholar transcript for each course, even if the course is taken in different schools.

Policy states that grades earned and offered for acceptance shall be based on official transcripts and shall be accepted at face value subject to validation if required by the EVAE administration and/or Academy's accreditation.

PRIVATE SCHOOLS AND HOME SCHOOLS

Please note: All Home School scholars seeking enrollment must be an approved Home-school through the resident's State Department of Public Instruction, must present documented proof of such approval, and must follow all residential State DPI guidelines before admittance is granted. Early View reserves the sole right to place scholars in its academic program.

If validation of the official transcript is deemed necessary for accreditation purposes by EVAE, then credits or grades shall be validated through a subject specific, EVAE approved exam which measures proficiency in course content. These tests must be passed for transfer credit to be awarded at time of enrollment to EVAE. Additionally, scholar performance will be monitored for the 1st month of school to measure academic success and if placement modification is needed. If placement modification is needed, parents will be notified; however, Early View reserves the sole right to place scholars in its academic program.

WITHDRAWAL POLICY

Parents must notify the Academy and submit a withdrawal form. Scholars must return any Academy property that may be in his/her possession and parents remain responsible for any fees or charges that have been issued to their account. The scholar's records will not be released until this procedure has been carried out.

PARENTS

PARENT INVOLVEMENT

The Early View Academy of Excellence encourages parents to involve themselves in all aspects of the Academy. Parents are encouraged to attend Academy functions, programs, services, and ceremonies.

Parents are required to complete a <u>MINIMUM</u> of 20 hours of volunteer service and/or participation. Please schedule your hours with the Academy office.

Parents may complete this obligation in a variety of ways. Some examples include tutoring, mentoring, sharing your skills or expertise; bringing class snacks; chaperoning a class field trip or fundraising. Background checks may be required for participation.

Parents are also given an opportunity to have a voice in Academy policies and procedures by participating on the Parent Advisory Board. Meeting times are agreed upon by participating advisory members.

<u>PARENT/ACADEMY COMMUNICATION</u> - Parent Communication is Very Important!!

The Academy welcomes communication from parents. Depending upon your need, you may choose to communicate via e-mail, phone, note or conference. Staff members will make every effort to respond to you within two (2) school days. Please follow the guidelines set out below.

Here is a simple guide for the use of each communication channel:

- (Brief) E-mail or note: If the same issues come up twice; then,
- (10 min.) Phone call: If further discussion is required; then,
- (20 min.) Face-to-face conference with your child's teacher or with an administrator; preferably before and/or after school

Email

E-mail works well when asking questions or making simple requests for information. All faculty, administration and staff members can be reached via e-mail.

Suggestions when e-mailing your scholar's teacher, principal, or any Academy staff:

- Please remember that e-mail is not confidential.
- Be concise.
- Make a simple request for information.
- If the concern is lengthy or involved, please request a conference instead of using e-mail.

The need to repeat e-mails over an extended period is a signal that the parent or teacher should request a conference.

Absent Excuses

Excuses are required when your child is absent from Academy for any reason. Be sure to include the child's full name, date, and reason for absence.

Parents may use notes to address simple requests or concerns. Please remember that notes are not always delivered to the Academy. If you do not receive a response and need one, please follow up with a phone call.

<u>PowerSchool – PARENT PORTAL</u>

Parent Portal allows parent the mobility and flexibility to stay current on academic and behavioral progress on a daily and weekly basis through their computer or mobile devices. Scholar Services is available to assist parents in setting up and navigating through the program.

Phones

Teacher Phones - Each teacher may be contacted by telephone. Parents and others should not expect classroom telephones to be answered during the instructional day when staff is teaching. Parents can call the main office and be connected to the teacher's voicemail.

Emergencies - If an emergency arises, call the main office for assistance.

Parent-Teacher Conferences (See Academy calendar)

Parent-Teacher conferences are held two times a year. When a conference is scheduled, attendance by the parent is mandatory. Teachers will not be interrupted by phone calls or conferences during class time.

PARENT CONTRACT Rev. 7/2019

As a parent/guardian of an EVAE scholar, I understand the importance of the parent contract as my expressed commitment to assist the school in creating a safe, nurturing, Christ-centered, academically enriching school community built upon mutual respect and responsibility. I understand and agree to comply with the following policies and procedures which have been explained to me by a school representative:

1. DRESS CODE (Refer to Handbook for full Dress Code Policy)

- i. Scholars are required to wear the proper uniform every day.
- ii. Scholars who arrive to school out of uniform will be required to have proper attire presented by parent, or they will be sent home.

2. ATTENDANCE/TARDIES:

- i. Scholar attends Academy regularly and arrives on time. Academy begins at 8:15 for all scholars. At 8:20am, scholar is considered tardy.
- ii. Scholars will not be admitted after 9:00am without medical documentation. If no medical documentation, parent must accompany the scholar into the office and speak to administration.

3. PARENTAL INVOLVEMENT:

- i. Required to attend parent conferences or send an adult representative.
- ii. Required to complete minimum of 20 hours of volunteerism. (See Handbook for details.)
- iii. Maintain communication with your scholar's teacher(s).
- iv. Utilize Powerschool to stay current with child's progress.
- v. Inform the Academy of changes to address, telephone numbers, or emergency contact information.
- vi. Ensure that your child has all health immunizations as required by law. Ensure that all relevant forms will be completed on time and turned into the Academy.

4. TRANSPORTATION:

- Transportation is a privilege and EVAE reserves the right to suspend/revoke privileges.
- ii. Parents are responsible for providing transportation for scholars not using EVAE transportation for any reason including bus suspension, after school detention, missed bus, etc.

BULLYING/NON-HARASSMENT POLICY Rev. 7/2019

Bullying is defined as unfair and one-sided behavior that involves people of unequal power. Such actions are purposeful and repeated and may include acts of physical and/or verbal, written, and electronic abuse/aggression as well as social exclusion. Bullying behavior can occur in writing, verbally, or electronically. This behavior can be perpetrated by an individual or by someone engaging in bullying behavior through another or on behalf of another.

Bullying obstructs the academy's ability to maintain the safety or welfare of scholars and staff. An act of bullying by an individual scholar, a group of scholars, or an adult is prohibited on the school bus, academy grounds or at school-related functions. Bullying and harassment of scholars or academy employees is also prohibited when perpetrated using data or computer software that is accessed through a computer, or other electronic communication devices. When scholars' off-school bullying speech or behavior results in a "substantial disruption of the learning environment," the scholar can be disciplined.

Early View Academy of Excellence is committed to making our academy a safe and caring place for everyone in our school community. It is the policy of EVAE that all employees, volunteers, parents, and scholars will deal with all persons in ways that convey respect and consideration for individuals regardless of race, color, national origin, gender, disability, sexual orientation, family situation, religion, or political affiliation. Any acts of harassment, bullying, hostility, or defamation, whether verbal, written, virtual or physical, that hinders the learning/teaching environment or that can be interpreted as threatening to others will not be tolerated and constitute grounds for disciplinary action including suspension and/or expulsion from school.

BULLYING/SEXUAL NON-HARASSMENT POLICY

Early View Academy of Excellence is committed to maintaining a learning environment that is free from bullying, sexual harassment, and sexual violence, where all employees and scholars can work and study comfortably and productively. Early View Academy of Excellence prohibits any form of sexual harassment or sexual violence. Examples of prohibited behavior that is unsolicited and unwelcome and/or sexual in nature include:

- Contact—suggestive looks, leering, or staring at another's body, gesturing, displaying sexually
 suggestive objects or pictures, cartoons, posters, magazines, Face Book, Twitter, or other social
 network postings.
- Written Contact—sexually suggestive or obscene letters, notes, invitations, or drawings. This
 also includes computer or mobile phone-generated messages, e-mails, or internet postings, text
 messaging and instant messaging; includes "cyberbullying" if Academy receives notification that

it occurred on school property and/or created a school disruption - because of "off campus" activity – postings, recordings, pictures, etc.

- Verbal Threat—sexually suggestive or obscene comments, threats, jokes including those about racial and gender specific traits, any sexual propositions, as well as comments about another scholar's body that are negative or embarrassing.
- **Physical Contact**—any intentional pats, squeezes, touching, punching, pinching, repeatedly brushing up against another's body, assault, or blocking free movement of any person.
- **Sexual solicitation or sexuality identification requests** Asking about other's sexual orientation or sexual status, and/or requesting sexual favors.

Verbal Harassment—ribbing or joking, including sexually suggestive language; defamation of character against scholar, staff and/or Academy. Harassment is just cause for disciplinary and/or police intervention and could lead to a scholar being expelled from Early View Academy of Excellence.

Any scholar who believes that s/he has been harassed should notify their teacher or adult in charge for appropriate follow-up. The Academy can initiate an investigation with or without a complaint or complaining party in any case in which a staff member observes or becomes aware of any potentially harassing behavior. The following steps will be taken as appropriate when dealing with incidents that involve harassment to any degree:

- o A clear account of the incident will be recorded and given to the Principal.
- o The Principal will interview all concerned and record incident.
- o Parents will be informed through a phone call and letter.
- Punitive measures will be used as appropriate and in consultation with teachers and parents but not limited to:
 - Official warning
 - Detention out of classroom
 - Exclusion from certain activities, e.g., recess
 - Short term in-Academy suspension
 - Out of Academy suspension
 - Expulsion

They must be turned off and secured in the scholar's assigned locker OR given to teacher until end of day (School day defined as being from the time a scholar arrives on campus each morning or once they have boarded EVAE transportation until school is dismissed for the day or they have departed EVAE transportation/grounds)

Violating the established electronics policy will result in the following:

- 1st Offense Device confiscated only returned to parent/guardian the following day, after school hours. EVAE administration or designee will safely secure any devices that are confiscated but will not be responsible for any alleged loss or damage by any device.
- **2**nd **Offense** suspension and required parent conference with administration.
- **3**rd **Offense** Additional offenses will be considered an act of insubordination and may warrant additional suspension and/or recommendation for expulsion for continual non-compliance of school policies.

SCHOLAR ACCEPTABLE USE POLICY

In several classes, we are introducing scholars to electronic mail and other global information resources, including the Internet. Early View Academy has developed a policy to enhance your child's education using the Internet.

Early View Academy will have special computer hardware in place that will restrict access to adult material and undesirable topics. However, it is not possible to completely block out all objectionable topics. As parents and teachers, we must teach scholars to be responsible consumers of information.

With this educational opportunity comes personal responsibility. Approved electronic activities must not contain profanity, obscene comments, sexually explicit material, expressions of bigotry, racism, or hate. Messages should not contain personal information that you would not want a stranger to have. This would include your name, address, telephone numbers, charge cards numbers, social security numbers or other personal information.

Parents and scholars please read through the policy listed below. The use of the Internet is a privilege, not a right, and inappropriate use will result in a cancellation of those privileges and possible school discipline.

Netiquette

- Be polite. Do not be abusive in any message to others.

- The scholar should respect the rights and privacy of other authorized users.
- The scholar represents his/her school and should do so in ways that are positive.

Parents, remember that you are legally responsible for your child's actions. Please stress to your child the importance of following the policies expressed in this document.

These signatures indicate that you have read the document and that your child agrees to adhere to the policies regarding Internet usage.

Under the state statute section 947.0125 scholars may be subject to criminal sanctions, if by means of signs, signal, writing, images, sounds or data, they threaten, intimidate abuse, or harass another person through electronic mail or other computerized communication systems. E-mail accounts and file materials are not private in nature and remain subject to monitoring by the school. The school and network administrators, with due regard for the right of privacy of users and the confidentiality of their data, have the right to suspend or modify Internet access privileges and examine files, passwords, account information, printouts, tapes, and any other material that may aid in maintaining the integrity and efficient operation of the system. Designated staff may search the file for potential violations and when there is evidence of a possible violation may view user's files, read mail, monitor keystrokes, and otherwise observe user's activities.

Scholars 8.01a Private School Tuition

Early View Academy of Excellence shall adhere to the Wisconsin Department of Public Instruction Milwaukee Parental CHOICE Program and Wisconsin Parental CHOICE Program statutes, rules and procedures.

School Choice Students – There is no tuition charge for an eligible Choice Student in grades kindergarten through 8th grade. However, the Academy may, in addition to the state aid payment it receives, charge a Choice student tuition in an amount determined by the school if both of the following apply: (a) the student is in grades 9 through 12; and (b) the family income of the student exceeds 220% of the federal poverty level. Married applicant's income is reduced by \$XXX when determining income eligibility whether the Academy will charge tuition (amount subject to change annually). Annual income limits will be provided.

Private Pay Students – Grades K-12 shall be charged tuition, a rate no less than the State aid Payments for a student enrolled full-time in the School Choice Program unless some form of tuition assistance is provided, internally or externally. However, the Academy reserve the right to charge an additional amount determined by the School Board if both of the following apply: a) the student is in grades 9 through 12; and (b) the family income of the student exceeds 220% of the federal poverty level. Federal Poverty Level. Married applicant's income may be reduced by \$XXX when determining income. Annual Tuition cost will be available by July 1 of each school year.

Technology 9.01 Electronics Usage

Early View Academy of Excellence offers electronic network access for scholars, teachers, and other staff members. The purpose of having the electronic network is to support the instructional program, including learning opportunities, business applications, information retrieval, searching strategies, research skills, and critical thinking.

This document identifies the acceptable use of the Early View Academy of Excellence network system (i.e., Internet, and email) and computer resources by the staff and scholars, as well as the obligation of school staff to educate, supervise, and monitor appropriate usage by students. Identified violation of appropriate usage may result in termination and/or expulsion.

Staff Acceptable Use of the Early Academy of Excellence network is to be used in a responsible, efficient, ethical, and legal manner and must be in support of the educational objectives and employee guidelines of the Academy.

Staff Unacceptable Use

Unacceptable use includes, but is not limited to, the following:

- 1. violation of copyright/trademark laws;
- 2. use of threatening or obscene material;
- 3. political or campaign materials;
- 4. sending or soliciting sexually oriented messages or images;
- 5. changing settings on computers;
- 6. disrupting the Academy work-day by the use of the Internet/social media during hours designated for job responsibilities and deadlines;
- using social media for personal use and/or posting activities relating to
 Academy incidents involving staff or scholars (i.e., fights, social relationships,
 or scholar interactions in the classroom or open area by LIVE or recorded
 means.
- 8. accessing programs not appropriate for educational use;
- 9. unauthorized use of password-protected network access or web sites;
- 10. accessing pornography, including child pornography.

- 11. Using offensive or harassing statements or language, including profanity vulgarity, and/or disparagement of others.
- 12. Engaging in the unauthorized disclosure, use, or dissemination of personal contact information regarding scholars. "Personal contact information" includes the scholars full name, together with other information that would allow an individual to locate the scholar, including their family names, home address or location, the scholar's work address or location, or the scholar's phone number.

Scholar Acceptable Use of the Early Academy of Excellence network is to be used in a responsible, efficient, ethical, and legal manner and must be in support of the educational objectives and employee guidelines of the Academy.

The material which scholars access through the Early View Academy's network system should be for class assignments or for personal research on subjects similar to those that a scholar might study in a class. Use for entertainment purposes is not allowed.

Scholar Unacceptable Use

Unacceptable use includes, but is not limited to, the following:

- 1. Use of personal cell phone or internet access device during school hours.
- 2. Accessing the following:
 - a. material that is obscene;
 - b. pornography, including child pornography;
 - c. material that depicts, or describes in an offensive way, violence, nudity, sex, death, or bodily functions;
 - d. material that has been designated as for adults only;
 - e. material that promotes or advocates illegal activities;
 - f. material that promotes the use of alcohol or tobacco or school cheating, or material that advocates participation in hate groups or other potentially dangerous groups;
 - g. material that is deemed harmful to minors.
 - h. Using social media for personal use and/or posting activities relating to Academy incidents involving staff or scholars (i.e., fights, social relationships, or scholar interactions in the classroom or open area by LIVE or recorded means.
